PURPOSE

The Board of Aldermen will hold a worksession with the chairs of the town's advisory boards to discuss term limits, appointments, the size of boards and commissions, performance evaluation of the various boards, and orientation of advisory board members.

INFORMATION

On January 15, 2002 the Mayor and Board of Aldermen discussed revisions to the Town's Guidelines for Selecting Advisory Board and Commission Members. The Board revised the guidelines to limit membership to one seat on the following boards and commissions: Board of Adjustment, Planning Board, Appearance Commission, Transportation Advisory Board, Recreation and Parks Commission, Cable T.V. Committee, Human Services Commission, Cemetery Commission, Environmental Advisory Board, Downtown Development Commission, Northern Transition Area Advisory Committee, Arts Committee and OWASA Board of Directors.

At that same meeting, the Board requested that the Agenda Planning Committee schedule a worksession with advisory board chairs to discuss term limits, appointments, size of boards and committees, performance evaluation of boards and committees, and orientation of members.

On February 5, 2002 the Mayor and Board of Aldermen approved an agenda for a "pilot" advisory board training session (Attachment C). This training session was tentatively scheduled for Saturday, March 9, 2002. The town staff would suggest that this training session be rescheduled to Saturday, April 3rd in order to allow the advisory boards to elect new chairs following board appointments scheduled for March 5th. The chairs of each board will be invited to designate a board representative to attend the training session.
