Dear Mike Nelson and Board of Aldermen,

Familias del Pueblo Road Race requests a contribution from Orange County for the 2003. Last year's race was an enormous success with over 1,000 runners, walkers, volunteers and sponsors involved with \$15,000 raised for the Youth Leadership Development Program of El Pueblo and El Centro Latino. We at El Centro Latino were dismayed to have La Fiesta move to Raleigh, but did want to keep the Road Race alive and in Orange County. We are aspiring to have the road race be the anchor event and in the future we will add other activities to it to make it the Orange County Latino Festival. For example, this year we will have 100 flags from many countries to enhance the tag line *Many Culture*, *One Race*. We will again have an Opening Ceremonies where parents and children alike parade around the track with the flags to marching music.

We will also have live music playing throughout the morning. The children's activities will again include track races and several piñatas. Last year's favorite picture was a little Chinese child swinging away at the piñata!

Again the proceeds will go to identify and support *El Centro Latino*, a not-for-profit organization, located in Carrboro, committed to improving the quality of life for Latinos in and around Orange County, North Carolina. They provide social and educational services and opportunities. They accomplish this through dedicated staff, volunteers, members, and allied organizations. Proceeds will also help El Pueblo's *Youth Leadership Development Program* foremerging and established leaders between the ages of 13-25 who are committed to develop their knowledge, skills and experiences to become productive North Carolinians and effective advocates for their communities.

The Chapel Hill Carrboro City Schools will again act as a sponsor in that they will waive all fees for McDougle School. We are approaching the town of Carrboro for a contribution to help offset the police and public works' cost.

We are requesting \$2,000 from the Town of Carrboro. If a decision could be made by July 28, then we can list you on our poster (2,000) and in the **88,000 inserts** that are being printed by The Herald Sun. There will be 10 other Ads where Orange County also will be listed in the months of August and September. You will also be listed on all volunteer and runner's T-shirts, which is an August 1<sup>st</sup> deadline.

## Section 7-22 Fees; Costs Incurred by Town

- (a) A basic minimum fee sufficient to cover the cost of advertising the public hearing in accordance with subsection 7-19(b) and to provide the notification required by subsection 7-24(d) shall be paid by the applicant. The amount of this fee shall be based upon an estimate of the expenses that will actually be incurred to provide the required notices.
- (b) In addition, if the town if requested to provide extra-ordinary services or equipment or the town administration otherwise determines that extraordinary services or equipment should be provided for reasons related to public health or safety, the Board shall take whatever action is necessary under the Local Government Budget and Fiscal Control Act to make available the necessary funds for the provision of such services or equipment.
- (c) The Board may require the applicant to pay to the town a fee sufficient to reimburse the town for the costs of any extraordinary services or equipment provided.
