Re: Appointment of Citizen to the Downtown Development Commission

Currently the DDC has three vacant positions. A number of citizens have expressed an interest in serving on the citizen's boards and listed the DDC as a choice. The Town has been working very hard with the boards support to accomplish the Board of Aldermen goals of increasing the commercial tax base, improving parking in the downtown, supporting current businesses and developing opportunities for new businesses to come into our town. To accomplish these goals, many citizens have participated in focus groups and government processes to help further the vision for Downtown, long range planning and social growth.

Peter Lee and Ruffin Slater have greatly contributed to these efforts and wish to serve on the DDC. Peter has completed one term and Ruffin Slater would serve for the first time. Ruffin is an active member on the Sustainability Council. Peter has served on the Art Center Board and would serve as a consumer voice on the DDC.

A third recommendation will follow as the DDC continues the review of applications.

Dear Ms. Williamson:

As you know, I was recently appointed chair of the Carrboro Environmental Advisory Board. Since that appointment, we have had two applications forwarded to us so that we might fill three recently vacated seats. In addition, I understand that one of our board members is up for reappointment.

Sarah Myers lives near downtown Carrboro and works for the university as a waste reduction specialist. She would bring greatly needed expertise concerning waste disposal and reduction as well as a passion for environmentally sustainable building and design. Her time in the peace corps in Moldova and as a carpenter in Carrboro will all be helpful and will compliment the skill set already present on the board.

Bob Taylor is a community resources coordinator for the nonprofit NCRCAP who also lives near downtown. He works as and has experience dealing with innovative ways to dispose of wastewater. His time in the Peace Corps in Honduras and as a resident of this area will be extremely useful. Again, his skill set is complementary to the skill set of the other members of the board.

Neil has been a member of the EAB for only a few months now, but has demonstrated his commitment through regular attendance at meetings and a level-headed approach to discussing problems. I look forward to working with him in his next term.

Therefore, I would like to respectfully submit to the board of aldermen the names of Sarah Myers and Bob Taylor as our recommendations for the new seats and Neil Flanagan for reappointment to his old seat.

Thanks for this opportunity to reinvigorate our board.

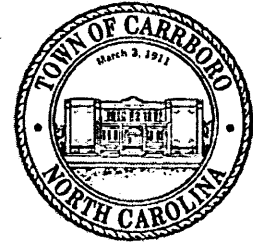

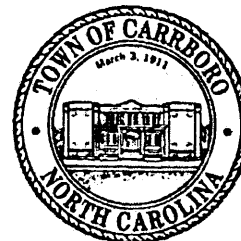
