## A RESOLUTION APPROVING THE MINOR MODIFICATION TO THE CUP FOR THE CARR MILL MALL LOCATED AT 200 NORTH GREENSBORO STREET TO ALLOW AN AWNING TO BE PLACED OVER THE OUTSIDE SEATING AREAS IN FRONT OF ELMO'S DINER

Resolution No. 135/2003-04

WHEREAS, the Carrboro Board of Aldermen approved a Conditional Use Permit for The Carr Mill Mall at 200 North Greensboro Street on February 11, 1976; and

WHEREAS, the applicant has requested a modification to allow the addition of an awning over the existing outdoor dining area; and

WHEREAS, the Administration has determined that the requested change is a minor modification, which requires approval by the permit issuing authority (in this case, the Board of Aldermen); and

WHEREAS, the Board of Aldermen finds that the applicant has satisfied the requirements related to minor modifications contained in the Land Use Ordinance.

NOW, THEREFORE BE IT RESOLVED by the Carrboro Board of Aldermen that the minor modification to the Carr Mill Mall conditional use permit located at 200 North Greensboro Street allowing an awning to be placed over the outside seating areas in front of Elmo's Diner is approved subject to the following condition:

• the signage of "Elmo's Diner" on the awning be reviewed prior to approval by the Appearance Commission.
