

**A RESOLUTION APPOINTING CATHERINE DEVINE AND THREE MEMBERS OF  
THE BOARD OF ALDERMEN TO THE SIDEWALK REVIEW COMMITTEE**

**Resolution No. 196/2003-04**

WHEREAS, On November 4, 2003, the voters of Carrboro approved a \$4.6 million general obligation bond issue for the purpose of constructing sidewalks and greenway trails.

WHEREAS, at its meeting on February 3, 2004, the Board of Aldermen approved the "Guiding Principles for Implementing Sidewalk Bond Projects," which identifies tasks to be performed by a Sidewalk Review Committee.

WHEREAS, at its meeting on June 1, 2004, the Board of Aldermen authorized the creation of a Citizen Sidewalk Committee composed of five members, three members from the Board of Aldermen and two Carrboro citizens, and authorized Town staff to recruit applicants for the two citizen seats on the committee.

WHEREAS, Catherine DeVine has submitted an application for one of the citizen seats on the Sidewalk Review Committee.

**NOW THEREFORE THE BOARD OF ALDERMEN OF THE TOWN OF CARRBORO  
RESOLVES:**

Section 1. The Board of Aldermen hereby appoints Catherine DeVine to one of the citizen seats on the Sidewalk Review Committee.

Section 2. The Board of Aldermen requests Town staff to continue to recruit applicants for the other citizen seat on the Sidewalk Review Committee.

Section 3. The Board of Aldermen hereby appoints the following three Aldermen to serve on the Sidewalk Review Committee:
