A RESOLUTION TO SUPPORT THE DEVELOPMENT OF A TEN-YEAR PLAN TO END HOMELESSNESS IN ORANGE COUNTY AND APPOINTING A CARRBORO REPRESENTATIVE TO THE PLANNING GROUP Resolution No. 98/2004-05

WHEREAS, the Board of Aldermen recognizes the need to work with Orange County, the Town of Chapel Hill, the Town of Hillsborough, the University of North Carolina and other housing providers to address the needs of the homeless in Orange County, and

WHEREAS, the problem can not be solved without all of the governments and housing advocates working together, and

WHEREAS, in October 2003, Triangle-area elected officials were briefed on the 10-Year Plan to End Homelessness initiative sponsored by the united States Interagency Council on Homelessness where the attendees were asked to begin a similar planning process in their localities. And

WHEREAS, Wake County and the United Way have developed a program that incorporates public forums and action-oriented workshops in the planning process for planning how to end homelessness. And

WHEREAS, Orange County, The Town of Chapel Hill, United Way, IFC Community House and the Community Initiative to End Homelessness (formerly known as the Continuum of Care) on November 18, 2004 hosted a Roundtable Discussion on Homelessness in Orange County with over 150 in attendance, and

WHEREAS, the attendees supported the idea of developing a ten-year plan to end homelessness and identified the need for the Towns of Carrboro and Hillsborough to be at the table.

NOW, THEREFORE, THE BOARD OF ALDERMEN OF THE TOWN OF CARRBORO RESOLVES:

Section 1. The Board of Aldermen recognizes the need to be represented in the planning process to end homelessness and agrees to make an appointment to the Round Table Planning Committee, which currently consists of staff representatives from Chapel Hill, Orange County, Triangle United Way, IFC Community House, and Community Initiative to End Homelessness.

Request for a Process to Develop a 10-Year Plan to End Homelessness in Orange County

I am writing on behalf of the Community Initiative to End Homelessness (formerly the Orange County Continuum of Care) to express ardent support for a resolution to implement a strategy for developing a local ten-year plan to end homelessness.

The Community Initiative to End Homelessness is charged with preventing and ending homelessness. Our goals are to encourage and promote community organization and education, resource development, an integrated continuum for housing and services, volunteer involvement and civic participation, individual and institutional financial commitment and advocacy for social justice and community responsibility. Our group meets bi-monthly and includes up to 50 members from non-profit organizations, government, schools, congregations, advocacy groups, foundations, private businesses and homeless or previously homeless individuals.

At our last meeting on January 10, 2005, the Community Initiative to End Homelessness voted to formally endorse a "Partnership to End Homelessness in Orange County." We believe a strong partnership between all municipalities and Orange County is essential to a successful ten-year planning process that is focused on ending homelessness.

The task of ending homelessness is vast and complex. The Community Initiative to End Homelessness is supportive of a ten-year plan to end homelessness for the following reasons:

- We believe firmly that no one in our community or beyond our community should go without a place to call home.
- All sectors of our community should be engaged in addressing and finding solutions to the complex issue of homelessness and poverty.
- A ten-year plan will create a set of strategies focused on ending homelessness, rather than containing the problem and making homelessness comfortable for those experiencing it.

The Community Initiative to End Homelessness stands prepared to contribute to this planning process. We are extremely pleased and encouraged by municipal and county efforts in addressing homelessness, in partnership and as a community.
