PURPOSE

The Mayor and Board of Aldermen will consider making appointments to the Planning Board and Recreation and Parks Commission. Aldermen Broun and Chilton will be making reports on the recommended appointees. The staff recommends that the Board adopt the attached resolutions.

INFORMATION

In February of each year some terms on all the town's advisory boards expire. Those persons whose terms expire in February 2005 were notified that their terms were expiring and thanking them for their service. They were told that if they wished to be considered for re-appointment, that they should re-apply for service. In addition, all positions were advertised.

On February 22, 2004 the Board of Aldermen made appointments to all advisory boards with the exception of the Planning Board and Recreation and Parks Commission. The Board requested that Alderman Broun discuss appointments with the Chair of the Planning Board, and Alderman Chilton volunteered to discuss appointments to the Recreation and Parks Commission with the Chair of that commission.
