

AN ORDINANCE AMENDING CHAPTER 6 OF THE CARRBORO
TOWN CODE RELATED TO STOPLIGHTS, STOP SIGNS, AND SPEED LIMITS

THE BOARD OF ALDERMEN OF THE TOWN OF CARRBORO ORDAINS:

Section 1. Article II of Chapter 6, Section 6-2, of the Carrboro Town Code is amended by adding the following to the list of intersections at which stoplights are required:

West Poplar Avenue at 54 Bypass*

Section 2. Article II of Chapter 6, Section 6-3, of the Carrboro Town Code is amended by adding the following to the list of locations where flashing red or yellow lights are required:

Other Locations: Jones Ferry Road* east of Davie Road
Jones Ferry Road* west of Davie Road

Section 3. Article II of Chapter 6, Section 6-4 (a) of the Carrboro Town Code is amended by adding the following to the list of intersections where stop signs are required:

Section 6. Article III of Chapter 6, Section 6-16 (b) (4) of the Carrboro Town Code is amended by adding the following street to the list of streets on which a thirty-five (35) mile per hour speed limit is established:

Homestead Road* (SR 1717) from a point 1.41 miles east of Old NC 86* (SR 1009) to the intersection of Rogers Road* (SR 1729)

Section 7. Article III of Chapter 6, Section 6-16 (b) (5) of the Carrboro Town Code is amended by adding the following street to the list of streets on which a forty (40) mile per hour speed limit is established:

Rogers Road* (SR 1729) from a point 0.11 miles east of Eubanks Rd* (SR 1727) to the intersection of Homestead Road (SR 1717)

Section 8. All provisions of any town ordinance in conflict with this ordinance are repealed.

Section 9. This ordinance shall become effective upon adoption.
