A RESOLUTION CREATING A NEW HORIZONS TASK FORCE Resolution No. 95/2005-06

WHEREAS, close to 300 households in northern Carrboro were annexed by the Town effective January 31, 2006; and

WHEREAS, the Carrboro Board of Aldermen have always sought feedback from residents and neighborhoods (as with the Neighborhood Forum), and in this case desired a formalized communication link between themselves and residents residing in this new area of the Town; and

WHEREAS, the Town has established guidelines for creating advisory boards and commissions; and

WHEREAS, the New Horizons Task Force will allow residents in this new area of Town to voice their thoughts and concerns to the Board of Aldermen;

NOW, THEREFORE, BE IT RESOLVED that the Board of Aldermen authorizes the creation of a New Horizons Task Force.

BE IT FURTHER RESOLVED that the Board of Aldermen will accept applications for two weeks following passage of this resolution, and that they will then appoint a chair, a vice-chair, and other members to the Task Force. All applicants shall complete an official committee application.

BE IT FURTHER RESOLVED that the New Horizons Task Force will meet at least once monthly and will be in existence until July 1, 2007.

BE IT FURTHER RESOLVED that the New Horizons Task Force shall report to the Board of Aldermen as requested by the Board and shall undertake such studies or perform such duties as the Board may request from time to time.
