- As a PhD student, I study pedestrian and bicycle oriented environments and their effects on health
- From August 2002 to August 2004, as a was a fellow at Active Living by Design (a Robert Wood Johnson Foundation-funded program which delivers grants to communities to create better built environments for integrating physical activity into daily life), I organized lectures with transportation experts on how to create more active-transportation-friendly environments, helped develop case studies of commuties succesful at improving their bike and pedestrian environment across the United States, and reviewed research on active transportation
- I participated in the 3 days of the visioning meeting with Dan Burden in Carrboro 2 and a half years ago
- I have participated in Chapel Hill's bike-pedestrian plan for the past year (attending town meetings and offering suggestion for improvements)

- I do not own a car and do all my travels by bike or on foot , and as such I have a very acute sense of the needs of cyclists and pedestrians in Carrboro

- I have been involved in bicycle advocacy for 13 years (although mostly in Paris, France, where I participated in the Townhall Bicycle Commission that led to the 150 km bike-lane network that now exists there)

- I have worked as an advocate and been on the executive board of environmental policy organizations many years (mostly in France) (as a result, I have a good sense of conducting efficient meetings)

**REASON(S) YOU WISH TO BE APPOINTED:** I would like to contribute to bettering the life of Carrboro residents by improving the bicycle and pedestrian environment in our town. I have both personal experience and educated knowledge of what works to create a good environment for cyclists and pedestrians, which I would like to use to benefit my community. Although a full time advocate in the past, my contribution to the community in the last 6 years has been mostly limited to living the life I believe in, and I would now like to take advantage of my understanding of these issues to participate actively in the decisions that will make my community a better place to live in.
