This letter is to inform you that June 30, 2006 is the expiration date of Terri Buckner's term as a member of the OWASA Board of Directors.

Ms. Buckner took her Oath of Office on June 23, 2005 and filled the unexpired term of Dr. John Smith, whose term expires on June 30, 2006. If Ms. Buckner is appointed by the Board of Aldermen this would be her first full three-year term.

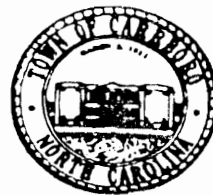
