# A RESOLUTION ENDORSING THE NORTH CAROLINA LEAGUE OF MUNICIPALITIES' STRATEGIC DIRECTIONS INITIATIVE Resolution No. 73/2006-07

WHEREAS, the North Carolina League of Municipalities has undertaken a strategic visioning process to determine how to continue to meet the needs of its members as the League approaches its second century of operation; and

WHEREAS, the Strategic Directions Initiative Steering Committee studied the history of the organization, the forces that shaped the League and the trends that are likely to occur; and

WHEREAS, the NCLM Strategic Directions Initiative Steering Committee has examined the strengths, weaknesses, opportunities and threats that face the League in the years ahead; and

WHEREAS, the committee has talked with municipal elected and appointed officials, as well as NCLM staff members, to determine what members value about the League; and

WHEREAS, the committee has proposed to strengthen the League by developing a mission statement that makes explicit why the League exists; and

WHEREAS, the committee is proposing core values that define how the League lives its mission, with these being: ethical; fair and equitable; financially sound; good government and public service are valuable; inclusive, collaborative, engage partners, stakeholders and external actors; innovative and forward-thinking; municipalities matters; nonpartisan; open and transparent; and unity; and

WHEREAS, the committee is proposing that the League focus on strengthening member communication, participation and engagement; strengthening the League's governance capacity; and strengthening policy development and representation of municipal interests in an increasingly regional, global and intergovernmental world; and

WHEREAS, the Carrboro Board of Aldermen has reviewed the proposed mission statement, core values and strategic directions developed by the Strategic Directions Initiative Steering Committee.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE TOWN OF CARRBORO:

Section 1. The Board hereby endorses the findings of the committee, encourages the NCLM Board of Directors to adopt the recommends, and move the League forward to its preferred future.

Section 2. This resolution shall become effective upon adoption.



## The Strategic Directions Initiative

Initiation's strategic visioning process. At the recent NCLM Annual Conference, held in Greensboro, members of the League's Strategic Directions Steering Committee presented a draft mission statement, core values and strategic directions that would shape the League as it begins its second century of operations.

The committee and the NCLM Board of Directors now are asking municipal officials to comment on the proposed mission, values and strategic directions. Each member municipality is being sent a CD with a visual presentation (and instructions for viewing), along with written materials to aid in the discussion.

"The steering committee has gone through a thoughtful process, drawing in information and participation from the members and the staff, and has crafted a mission statement, and come up with a list of core values that should define our work," said NCLM Director S. Ellis Hankins. "From that they have identified three areas for refocusing the League to ensure its continued success."

As NCLM Immediate Past President A. Everette Clark, mayor of Marion and a member of the Strategic Directions Steering Committee, explains, "The Board felt that the League's mission and strategic vision should be re-examined with an eye to the future. The organization has grown and changed dramatically over the past 20 years and so has our world. It has been some time since we stood back and discussed what we want the League to be in the future."

"Now we want all of our membership to look at what the committee has done and provide feedback and comments. That will give the Board the perspective needed to adopt a mission and strategic directions document for the League next year," Clark said.

Once the mission statement is adopted and strategic directions established, the League will develop a strategic plan to implement overall goals.

"This work will give us criteria to guide the decisions that must be made about specific programs and services to begin, continue or discontinue," said Hankins.

## The process

The strategic directions process began in June 2005 when the NCLM Board of Directors instructed the staff to develop a new strategic vision. The last formal strategic planning process had been completed a decade earlier.

The steering committee was appointed in September and began work in January. During the effort, elected officials, managers and other municipal staff, and NCLM staff provided information and input through focus groups and special meetings.

The draft mission statement, core values and strategic directions, along with highlights of the findings are included in the attached materials.

#### **Next steps**

After municipal officials provide comments and suggestions, the Board of Directors will revise as needed and then adopt a mission statement, core values and strategic directions. The next step will be development of a long-range plan to carry out the strategic directions.
