Dear Fellow Firefighters,

For well over 100 years firefighters in North Carolina have joined together in an Association for the purpose of finding ways to meet the changing needs of firefighters and their families. Over all those years the North Carolina State Firemen's Association has been one of the driving forces providing leadership and guidance to its members. The NCSFA has been an advocate for the firefighters and their families while providing educational and training opportunities to all its members. The Association fought tirelessly to secure good, solid legislation to protect our state's firefighters as well as providing essential benefits such as our line-of-duty coverage, our AD&D insurance coverage and our scholarship program.

In 2007 the Association will move its headquarters from Farmville to the Quorum Center in Raleigh. This is an important step in the life of the Association. This year's theme "**Firefighters Helping Firefighters**" requires that, in an atmosphere that becomes more political each year, the presence of officers and staff of the Association be in closer proximity to legislative action that so dramatically impacts your work.

The new office will provide 3000 square feet of space, will include facilities for meetings of the Association Board and committees, a place to meet with legislators and provide a more convenient location for members to conduct their business. We will be adding at least one new staff position in the coming months to supplement the growing demands of the Association, and plans are in place to add an additional position which is needed to expand and manage education and conference activities. This position will be added next year.

To support this important change, the insurance benefits, other ongoing programs such as scholarships and to meet the goals of our five-year financial plan the Executive Board has adopted an increase in member dues of \$5.00 per person beginning in 2007. The Board is committed to working within the perimeters of the financial plan and holding the line on increases as much as possible. We all know that it is difficult to control the cost of programs like our insurance coverage, but it is a vital part of our benefit package. The new revenue generated will improve programs, services and facilities.

The Association is committed to providing quality, professional service to its membership and will continue to work tirelessly on behalf of North Carolina Firefighters. We will as our mission statement says work to promote the best interests of our membership. Thank you for being a part of this wonderful organization. We look forward to serving you for many years to come.

ANNUAL CERTIFICATION OF FIREMEN

Failure to accurately and promptly report this information is violation of G.S. 58-86-25 and will automatically result in a loss or reduction of benefits.**
