Can the town staff answer the following questions for Carrboro citizens:

- 1) How does a citizen check to see if there are any livestock raising restrictions or any livestock slaughtering restrictions controlling their property?
- 2) How does a citizen check to see if there are any livestock raising restrictions or any livestock slaughtering restrictions controlling a neighbor's property?
- 3) Is there a public database or a town map which shows citizens where these restrictions are present? If not, then why not?
- 4) Is there any model deed restriction language that the town can provide to those of its citizens who wish to eliminating livestock raising or livestock slaughtering on their specific property or on any property within their homeowners' association control, should they have one? If not, then why not?
- 5) If livestock raising or livestock slaughtering restrictive language applies to a property on which these activities are occurring, how does a citizen enforce them? Do they have to sue their neighbor in court? Will town of Carrboro animal control officers enforce the provisions? If not, then why not?
- 6) If a neighbor is slaughtering animals on their property but refuses to follow these state guidelines, do you have to sue your neighbor to get compliance? Or do you have go to the state Ag Department to get compliance?
- 7) Will the town of Carrboro do anything to help you if your neighbor is engaging in animal slaughtering mindless of public health?

ON-FARM SLAUGHTER ACTIVITIES

I. PURPOSE

This document is issued to clarify the North Carolina State laws governing slaughter activities conducted on the farm.

- II. REFERENCES: North Carolina General Statutes 106-549-23 and 106-549.27
- III. CANCELLATION: MPIS Notice 6-03 dated 9-12-03
- IV. COMMON QUESTIONS ASSOCIATED WITH THIS ACTIVITY
 - 1. Q: Can I sell a live animal and let the buyer slaughter it on my farm?
 - **A:** No. Per North Carolina General Statutes 106-549.23, this slaughter activity must take place in an approved facility regulated by the North Carolina Department of Agriculture and Consumer Services, Meat and Poultry Inspection Division.
 - 2. Q: Can I slaughter animals of my own raising on my farm?
 - A: Yes. Per NC General Statute 106.549.27, this is permissible provided:
 - a. the meats and meat products derived from the animal are for personal use only (not sold to other persons or businesses)
 - b. the inedible parts (blood, internals, étc) are properly disposed of (transported to a licensed rendering plant or buried at least 3 feet deep and no closer than 300 feet to any flowing stream or public body of water).
 - 3. Q: How can I learn more about inspection requirements?

Please be advised that if you do not follow the guidelines described above, you could be in violation of the North Carolina Compulsory Meat Inspection Laws and/or the Animal Disease Act as well as the laws of other local, state and federal agencies that are responsible for such areas as water quality and public health. Violators of the North Carolina Compulsory Meat Inspection Laws and/or the Animal Disease Act may be assessed a civil penalty up to \$5,000.00 per violation and/or subjected to criminal prosecution.
