#### **PURPOSE**

To request approval from the Board of Aldermen to enter into an installment financing agreement with SunTrust Banks, Inc. for the purchase of vehicles approved in the FY 2010-11 annual budget.

#### **INFORMATION**

Through its capital improvement plan the Town establishes a schedule for the purchase and replacement of vehicles and equipment through lease purchase financing. Funds to purchase specific vehicles and equipment are appropriated each year in the adopted annual budget for financing over a five year loan term. Below is the list of vehicles and equipment approved for purchase in FY 2010-11.

The Town is not required by law to request proposals to finance these vehicles; however, to make sure that the Town gets a competitive financing rate and terms, a request for financing proposal was distributed to 23 banks and brokers. The following 5 financial firms responded to the request for proposal: SunTrust, RBC, Pinacle Public Finance, US Bank, and Harrington.

In evaluating the proposals the important factors were the effective interest rate offered and the total financing cost. As Attachment B shows, SunTrust's Option 1 proposal offers the most competitive interest rate of 1.555% and financing arrangement for a 5-year term financing.

#### FISCAL IMPACT

The adopted FY 2010-11 budget includes \$560,500 for the purchase of the above vehicles and equipment. Due primarily to our ability to "piggy-back" on state contracts, the Town was able to realize a budget saving of \$84,101. Rather than borrowing \$560,500 as planned for in the budget, the Town only needs to borrow \$476,399.

## **RECOMMENDATION**

The Board of Aldermen is requested to approve the attached resolution designating the installment purchase contract as tax-exempt obligations of the Town; and award the financing contract to SunTrust for the equipment and vehicle purchases listed above.
