PURPOSE

The Board of Aldermen is asked to receive an update on the Triangle Regional Transit Program, including the Durham-Orange Corridor Alternatives Analysis and associated regional transit planning efforts.

INFORMATION

Triangle Transit has completed the Durham-Orange Corridor Detailed Definition of Alternatives Technical Report, which evaluates the costs and benefits of various regional transit improvements between Orange and Durham Counties. These improvements include light rail transit (LRT) and bus rapid transit (BRT). Also included in the evaluation were transportation system management (TSM) and the No-Build alternative. The report is part of an Alternatives Analysis process that is necessary to apply for transit funding from the Federal Transit Administration's New Starts program. The report recommends that light rail transit be advanced as the LPA.

The Durham-Chapel Hill-Carrboro Metropolitan Planning Organization's Transportation Advisory Committee (TAC) will be considering approval of a Locally Preferred Alternative (LPA) at its February 8 meeting. This will follow a public hearing scheduled for the TAC's January 11 meeting. This agenda item is an opportunity for the Board to provide comments that will be included in the TAC's consideration of an LPA.

Although the proposed corridor does not extend west into Carrboro, several implications of the Alternatives Analysis are relevant for Carrboro:

• If LRT is selected, the station location on UNC's campus will affect the feasibility of a future extension into Carrboro. The recommended station location, A3, is off of Hibbard Drive south of Mason Farm Road (Attachment C). The Board heard some of the implications of UNC station location at its November 9, 2010, meeting (see links below), including a presentation of a white paper completed by Triangle Transit, available as an

- The LPA selection affects the cost of the regional transit system, which in turn affects the financial implications of the Bus and Rail Investment Plan in Orange County. A report on this plan was provided to the Board of Aldermen on May 24, 2011. It is linked here: http://townofcarrboro.org/BoA/Agendas/2011/05_24_2011.htm.
- The investment in a fixed guideway transit corridor may increase mobility for Carrboro residents, especially those without motor vehicles available to them, even if it means having to take a feeder bus, bike, or walking to get there.
