PURPOSE

Staff of the North Carolina Department of Transportation will provide a report/presentation on the project.

INFORMATION

Right of way acquisition for the Smith Level Road project (State Transportation Improvement project U-2803) began in fall 2011. Final construction plans are scheduled to be complete in September 2012 in order for the project to be let for construction in December. Soon after NCDOT right-of-way agents began to contact property owners, questions were raised about the project details in relation to the plans approved by the Town in September 2010. A meeting with NCDOT staff was scheduled for November 15^{th} ; utility engineering staff had come prepared to respond to questions about utility easements and had not prepared a presentation on the project as a whole. The Board of Aldermen requested additional information. Town and NCDOT staff met in December to discuss the Board's request and to identify a schedule for obtaining additional information. A memo summarizing the December 19^{th} meeting is attached (*Attachment B*). The Board of Aldermen received additional communication from property owners and in discussing on January 17, decided to request a meeting/report on the project from state legislators and NCDOT Board of Transportation district representative (*Attachment C*). The Town Clerk has attached the emails and letters from concerned citizens (*Attachment D*). A meeting was scheduled with a report on the following information requested:

- 1) Description of the project (including scope and expected schedule)
- 2) Description of changes to the plans made since right-of-way acquisition began
- 3) Comparison of the plans to the project as shown on the plan approved by the Board of Aldermen on September 28, 2010
- 4) Description of all easements, including locations, purpose and type of easements, and any restrictions on activities

This memo serves as an update regarding the December 19th meeting between Town of Carrboro staff and NCDOT staff regarding the Smith Level Road improvement project.

The purpose of the meeting was to discuss the most recent revisions to the Smith Level Road improvement plans in comparison to the public hearing map that was approved by the Board of Aldermen in September 2010, discuss a public meeting to review plans with concerned residents and to discuss the status of ROW/easement acquisition for the project. NCDOT staff presented updated plans that included numerous changes to the easements needed. NCDOT staff also agreed to provide the Town documentation explaining the purposes of the various utility easements, which will be passed on to the affected residents. The updated plans and a written document explaining the changes will be available on the Town's website once they are received from NCDOT staff in late January. Changes include:

- Relocated permanent utility easement (PUE) on southeast corner of Culbreth and SLR (Teal Place) to north side of road to address resident concerns.
 Minor disruption of screening required but can be replaced. Permanent utility easement still needed on driveway for water meter(s).
- Narrowed aerial utility easement and permanent utility easement at northeast corner of Culbreth and SLR (Covenant Place).

- Eliminated North BPW utility easement except for corner
- Reduce Willow Oak easements, including impact to neighborhood entrance sign in median; improvements are still expected to impact corners and rock walls there.
- Reduced easements on SLR by Berryhill, relocated aerial utility easement to east side of SLR.
- Three Berryhill parcels will require 14 feet drainage utility easement beyond ROW. (Addresses not known at this time, will be shown on plans).

The preferred practice for obtaining easements, as expressed by NCDOT staff, is to meet with individual property owners singly or in groups where the properties are similarly situated. Where there are multiple properties affected and an existing HOA, the HOA is approached for assistance in setting up group meetings. NCDOT staff expressed willingness to speak with individual property owners, and hold group meetings through the homeowner's associations to discuss the plans and easements that are now needed where appropriate. Town staff asked to be kept informed of these meetings, and offered to assist in securing locations for the meetings, if needed.

NCDOT ROW staff will be contacting homeowners in early January with the updated and reduced easement requests. Their construction plan preparation and construction schedule necessitate ROW acquisition proceeding concurrent with working out final details of the easements.

Town staff has worked consistently to forward resident concerns to appropriate NCDOT staff, and in turn communicate with the Board and affected residents the answers received from NCDOT, and will continue to do so.

The Carrboro Board of Aldermen had an abortive meeting with utility engineers from NCDOT toward the end of 2011. We had been prepared to hear a presentation on NCDOT's latest changes to the Smith level Road plan, but the engineers had expected to come answer questions, not make a presentation. Dear Mayor Chilton, Board of Aldermen and Matt:

As you have been made aware, the residents of the Berryhill neighborhood are deeply disappointed regarding the proposed changes to be made to Smith Level Road. As you requested, in preparation for the February 7, 2012 public Town meeting with the North Carolina Department of Transportation (NCDOT), we have detailed below the specific concerns we continue to have about this project and propose these changes:

- Relocate Easements to East Side of Smith Level Road. The amount of real property condemned for all homeowners adjoining Smith Level Road exceeds what was originally presented. No real and personal property of any homeowner would need to be condemned if the drainage easements affecting these properties were located along with the power lines on the east side of Smith Level Road (see Figure 1, a-c).
- Eliminate Line of Sight Condemnation. According to the NCDOT line of sight specifications, 3 stone walls marking the Berryhill neighborhood entrance along with several magnolia and holly trees will be torn down. In addition, considerable portions of at least two corner neighbors' back yards will be lost (See Figure 2, a-c). This is unacceptable. First and foremost, vision is not obstructed along the existing Smith Level Road sight line by the Berryhill neighborhood. As shown in Figure 3, a driver stopped on BPW Club Road looking north along Smith Level Road has an unobstructed view all the way to the bridge. The same is true looking from Willow Oak Drive to the bridge. (Please see Appendix A for further discussion and illustration of these line of sight issues.)
- Install Traffic Light at Willow Oak Lane and Smith Level Road Intersection. We object to the decision to eliminate left turns from Willow Oak Lane onto Smith Level Road. This will require traffic needing to turn left off of Willow Oak Lane to instead drive through the neighborhood to BPW Club Road or to make a U-turn at BPW Road, causing additional time, gas use and safety concerns. Our objection is further based on the fact that Manor Ridge Drive and Orchard Lane are narrow, low visibility residential streets with a high density of children, pets, pedestrians, cyclists and parked cars. The Berryhill neighborhood

consists of 104 homes with only two entrances, both onto Smith Level Road. By eliminating a left turn into and out of Willow Oak, the neighborhood is effectively reduced to one functional entrance. The lack of a traffic light and pedestrian cross walk at Willow Oak encourages downhill speeding to the next light at the entrance to Frank Porter Graham Elementary School, which is an accident waiting to happen. In addition, installing a traffic light at Willow Oak Lane would eliminate any remaining line of sight concerns and eliminate the need for line of sight property condemnation.

Install Pedestrian Crosswalk at the Intersection of Willow Oak Lane and Smith Level Road. Bus stops exist on each side of Smith Level Road where it intersects Willow Oak Lane. To promote pedestrian safety, install a painted pedestrian crosswalk along with the proposed traffic light across Smith Level Road at this intersection.

The NCDOT has misrepresented and misled the Town of Carrboro and the residents of Berryhill on this project. In addition, we believe it is highly inappropriate for the NCDOT to be making property acquisition offers to the neighbors directly impacted by the expansion before the final expansion plans have been revealed, discussed and approved by the residents of Berryhill and the Board of Aldermen.

We call on the Town of Carrboro to ensure that the NCDOT be held accountable to the original plan that was agreed upon, along with the addition of a stoplight and pedestrian crosswalk at Willow Oak Lane.

Thank you for considering our concerns.

We look forward to working with you to find an amenable solution that won't severely impact the lives and real property of the residents of Berryhill.

Summary of Berryhill HOA issues with the current DOT proposal:

- 1. Avoidable taking of Berryhill residential property due to the DOT proposed relocation of utilities from the East side to the West side of Smith Level Rd between Morgan Creek and BPW Rd. The existing utility location already allows eastward expansion without the disruptive taking of residential land;
- 2. The unsafe funneling of increased traffic flows onto narrow Berryhill residential streets due to the DOT proposed dividing of Smith Level at Willow Oak with a hard median.

The latter DOT proposal would prevent left turns out of, and into, Berryhill at Willow Oak, unnecessarily funneling these traffic flows through Orchard Lane. Our objection is that these are narrow, poorly lit, low visibility residential streets with a high density of parked cars, pedestrians, cyclists and children.

Berryhill HOA proposed resolution for the DOT proposal:

- 1. While DOT installs sidewalks & bike-lanes, retain the utility easement on the **East** side of Smith Level Rd between Morgan Creek and BPW Rd, to minimize Eminent Domain taking of residential property;
- Retain the current Smith Level Rd soft median turn lane configuration at Willow Oak OR Install a Two-Way Turn Lane (TWTL) at Willow Oak (similar to Hwy 86/MLK Jr. Blvd) – OR – Install a traffic light for traffic exiting or entering Berryhill at Willow Oak.

Appendix A: Sight Distance Concerns

The NCDOT defines Sight Distance as:

"The area that establishes a clear line of sight for a waiting vehicle to see oncoming traffic and make turning movements into or out of a street or driveway connection safely or for traffic to see entering or waiting vehicles."

With that definition, and following the guidelines laid out in the NCDOT manual to review the existing and proposed sight distance at a few intersections, the NCDOT took the following steps. Ground images were taken from the position of a parked car, behind and designated stop or crossing. Aerial images were overlaid with the drawings on the Town of Carrboro web sight to best estimate the impact of the proposed changes.
Outlined in the images below are sight distances to 350 feet that meets the NCDOT Policy on Streets and Driveway Access, and exceeds the NCDOT Traditional Streets and Neighborhood Development Guidelines, along with the Carrboro guidelines. The white stars indicate approximately 350 feet following the 100 feet per 10 mph on the Policy on Streets and Driveway Access.

It is apparent from the illustrations below that the NCDOT proposed Berryhill property condemnation to allow construction to accommodate line of sight guidelines is unnecessary.

Question: If this is correct, the current plans do not require property acquisition for any aerial utility easements on the west side of Smith Level Road between Frank Porter Graham Elementary School and BPW Club Boulevard. Is this understanding accurate?

Traffic Pattern Changes

 Eliminate left turn from Willow Oak Lane onto Smith Level Road--NCDOT's current plans include a median on Smith Level Road between Frank Porter Graham Elementary School and BPW Club Boulevard. This median will prevent Berryhill residents from turning left off of Willow Oak Lane onto Smith Level Road. NCDOT is proposing a U-turn at BPW Club Boulevard to address this change. This change may require Berryhill residents to turn right onto Smith Level Road and make a U-turn at BPW Club Boulevard to head North on Smith Level Road.

Question: Is this understanding accurate? Do the plans include a protected left turn arrow for the U-turn at BPW Club Boulevard? If not, can one be included?

Question: What is the technical basis for excluding a left turn off of Willow Oak Lane onto Smith Level Road?

• Add sidewalks into Berryhill neighborhood — NCDOT's current plans include adding sidewalks on the west side of Smith Level Road between Frank Porter Graham Elementary School and BPW Club Boulevard. This includes adding sidewalks at the neighborhood entrance at Willow Oak Lane.

Question: Will the new sidewalks connect to existing sidewalks and enter the neighborhood on Willow Oak Lane, essentially providing continuous sidewalks from Willow Oak Lane to the intersection at Frank Porter Graham Elementary School?

Dear Mayor Chilton and Board of Aldermen:

The residents of the Enclave neighborhood are deeply disappointed about the proposed changes to be made to Smith Level Road as described by representatives of the North Carolina Department of Transportation (NCDOT) at the Carrboro Board of Aldermen (BOA) meeting on Tuesday, November 22, 2011. Fundamentally, the NCDOT has unilaterally changed the original agreement between the BOA and the NCDOT. These proposed changes contradict the spirit of compromise and cooperation that was arrived at through many years of discussions between the Town of Carrboro and the NCDOT regarding the expansion of Smith Level Road. Consequently, the residents of the Enclave neighborhood are asking the BOA to refuse right of way to the NCDOT until the following issues and concerns are adequately addressed to residents' satisfaction.

- Real Property Condemned. The amount of real property condemned for all homeowners adjoining Smith Level Road exceeds what was originally presented. Based on all indications from NCDOT, the expansion will come into our properties at least an additional 10-15 feet. This directly impacts the real property of all homeowners in the Enclave.
- Bury Utilities (Figure 1). As currently planned, the Aerial Easements proposed on our property would take away our current viewshed. We feel that burying any and all utilities would help protect our viewshed (we could replant any vegetation that would be removed due to construction). Caramore Incorporated, as well as many other residences along Smith Level Rd, agree that burying the utilities would be the best option to protect our homes from unnecessary power lines.
- Move DOT Easement by Unit 533 (Figure 2). NCDOT proposes a Guy Easement directly adjacent to a residence. We ask NCDOT to move that easement to an unused well location 30 feet away that is still located on Enclave property but is less detrimental to our homeowners.
- Move easement lines further away from homes (Figure 3). The current utility easement lines come to close to private residences which effectively takes away the ability to maintain a garden, grow bushes/trees for privacy, or create a green barrier for themselves.

Move DOT Utility Easement & Right of Way to the other side of the road where power lines & sidewalks already exist. The powerlines that are currently in place along Smith Level Rd. zigzag all along the road. We ask that DOT and the Utility Companies bury these utility to prevent the current viewshed from being completely destroyed. Currently, on the west side of the road, there is a sidewalk. What is the purpose of destroying the existing sidewalk to create another sidewalk?

Our neighborhood appreciates your attention to our concerns. We are asking that the Town of Carrboro (Board of Aldermen & Staff) to please arrange and facilitate the meeting between the residents of the Enclave and the NCDOT. Dear Mayor Chilton and Board of Aldermen:

Those of us that live in Teal Place are disappointed about the proposed changes to be made to Smith Level Road as described by representatives of the North Carolina Department of Transportation (NCDOT) at the Carrboro Board of Aldermen (BOA) meeting on Tuesday, November 22, 2011. Although the NCDOT has updated the size of the easement along Culbreth Road, the large chunk of property on the Smith Level Road side of our development has been left unaltered.

Below are some of the concerns we still have regarding the proposed changes to the project, and we ask the Carrboro Board of Aldermen to refuse right of way to NCDOT until our issues are adequately addressed to the satisfaction of the Teal Place property owners' satisfaction.

Property Value Deflation. The amount of real property condemned for the homeowner of Unit E adjoining Smith Level Road devalues the property value of all the units in Teal Place.

Move easement lines further away from homes (Figure 1). The current utility easement lines come too close to private residences which effectively takes away the ability to maintain a garden, grow bushes/trees for privacy, or create a green barrier for themselves. Specifically, the stake closest to Unit E measures 16' from the homeowner's building.

Reduce the Line of Sight requirements for the Southeast corner of SLR at Culbreth Road (Figure 2). As it currently stands, the amount of trees, shrubs and other green barrier items will be completely raped from the area, providing no protection from traffic, noise and pedestrians. If the line of sight requirements were removed, we would not have to lose our privacy.

Our neighborhood appreciates your attention to our concerns. We are asking that the Town of Carrboro (Board of Aldermen & Staff) to please arrange and facilitate the meeting between the residents of Teal Place and the NCDOT. We believe it is essential that our town representatives hear the same information that the NCDOT presents to the residents of our neighborhood. We look forward to working with you to find an amenable solution that won't severely impact the lives and real property of the residents of Teal Place.

PURPOSE:

The purpose of this agenda item is for the Board of Aldermen to consider revised criteria for the Town's Business Revolving Loan Fund and to update the application form based on the proposed criteria.

INFORMATION:

The Business Revolving Loan Fund was established in 1986 utilizing CDBG program income and has generated over \$1,000,000 in investment in the Town of Carrboro Business community since that time. The proposed new criteria reflect current business trends, Carrboro's economic development philosophies and the information that is needed by the ESC and the Board of Aldermen in making loan decisions. Generally, the proposed criterion simplifies the language and makes the requirements more streamlined and user-friendly. Attached is a side by side review of the current standards and the proposed new language. Some of the more notable changes are the loan to job loan amount requirements. The existing standards require one job per \$10,000 in loan funds, the proposed new criteria would allow for one full-time job per \$25,000 in loan funds. This revision is consistent with the NC Department of Commerce standards for CDBG programs that require job creation or retention. Some of the other changes and requirements address more recent issues dealing with records confidentiality, collateral requirements, business planning and financial forecasting requirements, identification of other forms of capital, etc. Updating the criteria may have the effect of encouraging more applicants due to the stream-lined, user friendly process, thereby continuing to build the fund. The ESC has reviewed and discussed the proposed changes and recommends approval by the Board of Aldermen.

PURPOSE:

The purpose of this item is for the Board of Aldermen to review the Baldwin Park garden proposals and staff report and establish whether the gardeners can move forward with the garden expansion proposal, rain catchment plan and signage request.

INFORMATION:

On January 17, 2012, The Baldwin Park Gardeners presented proposals which included expansion of the current garden perimeter, placement of the cistern and shed, garden signage and installation of rainwater catchment system. At that time, staff provided a few points for the Board to consider:

- Along the edge of the proposed expanded garden site is a steep slope and stream buffer that should be considered.
- As a matter of practice the Town has not funded signs for citizen driven projects. In the past, <u>donated funds</u> have been used to pay for the signs for these types of projects.
- The garden items left outside of the fence currently create safety and liability issues. These supplies have been outside of the fence for over a month and Staff requests that smaller items be placed inside the fence as soon as possible.
- OWASA staff had not evaluated the proposal to cross the OWASA easement.

Town Staff, OWASA and NC League of Municipalities reviewed the requests to determine their impact on Baldwin Park. This report will cover each consideration individually.

Expansion of current garden perimeter

The gardeners requested 2,160 additional feet for the garden which would accommodate 18 new garden plots. If granted the expansion, the additional space is more than 50% of the original garden. The stream restoration and storm water management project and the community garden have greatly impacted the open and useable space of this 2.5 acre park.

The Land Use Ordinances establishes water quality buffers on streams in town. The buffer on the stream to the west of the garden is 100 feet wide. It is a two tier buffer, with the nearest 50 feet receiving more protection than the 50 feet farther from the stream. The minimum buffer

required by the Jordan rule for streams such as this one is 50 feet total with a more protected zone within 30 feet of the stream. Extending the garden as has been proposed will create a larger footprint at that edge, and perhaps some/more area within 30' of the stream.

Should the Board decide to allow the gardeners to expand the garden, staff recommends a 25-30 feet expansion to the north end of the garden while maintaining the current 25 feet buffer between the fence and the stream instead of the 45 feet requested during the presentation (see attachment D). Additionally, staff recommends utilizing the existing space in the current garden to add needed plots (see attachment E).

Staff also recommends maintaining the appearance of garden by and suggests that the gardeners use the same materials as those used in the original construction of the garden perimeter and fencing. This would help maintain the uniformity and durability of the garden.

Placement of cistern and shed

Small garden items left outside the fence were placed inside the fence prior to the January 17, 2012 Board meeting. The cistern and shed were left outside the fence and the gardeners requested that they stay outside the northwest corner of the fence. Because of its function retaining rainwater, the cistern appears to be an allowable activity within the water quality buffers on the site, so long as it is located outside of Zone 1 (i.e. 50 feet from the stream on the west and 30 feet from the stream on the east). The shed is not an allowable activity within the water quality buffers. Staff will work with the garden members to identify appropriate locations for both structures in accordance with the Town's water quality buffers.

Staff recommends that the shed should be locked when gardeners are not in the vicinity and the cistern should have a locking valve so that it is secured when not in use. Also, for safety reasons a certification from an engineer stating the proposed platform(s) will hold the cistern and shed should be obtained.

Garden signage

The Carrboro Parks Project requested that the town pay for a garden sign which includes a list of donors and contact information. The cost is approximately \$200. We recognize and appreciate the Carrboro Parks Projects past and current fundraising efforts. Staff noted in the January 17th abstract that as a matter of practice the Town has not funded signs for citizen driven projects. In the past, donated funds have paid for the signs for these types of projects. The town has accepted donated funds and used the funds to purchase and/or install various amenities such as recognition signage. Any signage proposed for the garden must comply with Land Use Ordinance provisions. In previous situations, signs containing references to commercial supporters of a project could not meet the LUO definition of a sign (i.e. commercial messages could not be visible from a right-of-way). Signs that have been installed in association with other park projects have been reviewed by Town staff and this step will be needed in this instance as well.

Staff recommends the Carrboro Parks Project and the Baldwin Park Gardeners continue their fundraising efforts to purchase a sign. Recently staff shared the Nourishing North Carolina One Garden At-A-Time grant opportunity with the gardeners. This grant is a cooperative effort between Blue Cross Blue Shield (BCBSNC) and the North Carolina Recreation and Parks Association (NCRPA). We will continue to share opportunities. The Recreation and Parks Department can facilitate purchase and installation of the sign after receiving the donated funds.

Installation of rainwater catchment system

The gardeners would like to use volunteers to install gutters on the pavilion, trench and install PVC piping across the park to hook up to the cistern near the garden.

Staff requested a risk opinion from the League of Municipalities to determine whether volunteers should complete installation and trenching in the park. We were informed that the volunteers are not covered under workers compensation because they don't work for the Town or under general liability insurance because it is used for injuries to people or property caused by the negligence of the insured. Based on this information using staff or general contractors would be a protected direction to consider.

The addition of gutters to the shelter can be considered an improvement to an existing structure maintained by the Town, and therefore Public Works will install the gutters and downspout at Town expense. The gutters will help reduce erosion caused by water draining off the drip edge of the roof, and reduce splash/spray entering the interior of the shelter during rain events. Also, with the work being performed by either Public Works crews or a contractor hired by Public Works, staff questions concerning liability and proper installation will be addressed. Public Works staff will work with Baldwin garden representatives to coordinate the installation and connection of the downspout to other piping or water storage units.

The trench work and location proposal was given to OWASA for comment. Staff also met with an OWASA staff member onsite. The gardeners propose digging a 12" deep trench to bury the PVC in connecting to the cistern. OWASA confirmed the proposed route to make the connection would cross the OWASA sanitary sewer easement and that they may need to access this easement with equipment that weights 18,000 lbs. (see attachment C.) PVC pipe may have a problem supporting this weight. Ductile iron pipe or at minimum a 6" steel casing pipe enclosing the PVC across the 30' easement is recommended. Additionally, marking tape should be placed 6" above the pipe during installation. Public Works and OWASA will also need to review final plans and the timeline for the installation. Once the plan is approved, OWASA will issue a letter of encroachment to the gardeners. OWASA also requires a sign be attached on the pavilion after the work is completed notifying the community and others that a buried water line is present.

Staff recommends the installation of the water line connecting to the cistern be done by licensed contractors and the gutters and downspouts by Public Works.

FISCAL IMPACT

The total fiscal impact listed is based on staff recommendations. Gutter and downspout installation is approximately \$450.

RECOMMENDATION:

Town Staff recommends that the Board of Aldermen adopt the attached resolution.

WHEREAS, the Baldwin Park Gardeners presented a Cistern – Shed Placement and Rain Catchment Proposal and sign request for consideration on January 17, 2012; and,

WHEREAS, Town staff, OWASA and the NC League of Municipalities reviewed the requests to determine their impact on Baldwin Park; and,

WHEREAS, Town staff is sensitive to the time constraints related to the upcoming growing season and will be readily available to review the plans with the gardeners, and

WHEREAS, Town staff has provided a report for consideration.

NOW, THEREFORE BE IT RESOLVED by the Carrboro Board of Aldermen that the Aldermen accept the staff report and authorize the use of additional parkland, but subject to the following conditions:

- 1) That staff and the Baldwin Park Gardeners determine an appropriate, final location for the shed and cistern. The location must be outside any stream buffers, easements, or similar constraints located on the property; and,
- 2) That Town staff and OWASA will need to receive final plans that have been approved by a licensed engineer and the timeline for the installation. Once the plan is approved, OWASA may issue a letter of encroachment to the gardeners.
- 3) That once sufficient funds have been raised by the gardeners for signage, that staff will provide support for the purchase and installation of the signage.

Proposal to Install Rainwater Collection System for the Baldwin Park Community Garden

This proposal is in response to the community meeting held on the evening of September 14, 2011. The Baldwin Park Community Garden Steering Committee (BPCGSC) has discussed with Town staff its desire to move forward with the plan for the Baldwin Park Community Garden by installing a rainwater catchment system to supply water to the garden plots. The rainwater collection system has been a part of the plan for the structure of the community garden and is referenced in Attachment B of Resolution No. 37/2010-11 in which the Town authorized the creation of the BPCG. The BPCGSC proposes to collect rainwater from the roof of the shelter at BP and pipe it to a 1100 gallon cistern outside the garden's existing perimeter fence. We believe this plan will provide the greatest convenience to the gardeners and least impact to other visitors to the park and those using the shelter in particular.

Purpose and Need for Cistern

While rainfall is typically abundant in central North Carolina, there are unpredictable periods of dry weather during which supplemental irrigation is necessary to keep vegetable crops healthy. A connection to the public water supply, while reliable, would be both prohibitively expensive for the Garden and out-of-line with the Town's priorities regarding acceptable uses of our precious and limited public water supply when other options are available. However, rainwater collection from the nearby roof of the park's picnic shelter has been identified as an alternative water supply for the garden and will provide a very public example of the Town's stewardship of our natural resources. It will reduce storm runoff from the shelter's impervious roof and use the discharge to enhance the cultivation of crops grown by the garden's participants.

The roof coverage of the picnic shelter at Baldwin Park is roughly 25 feet by 28 feet and the roof runoff is expected to yield 445 gallons per inch of rainfall. One inch per week is a typical crop application rate during critical growing periods, though, tomatoes, for example can require nearly 1.5 inches per week according to the NC Cooperative Extension Service. For the 22 raised bed gardens at BPCG this would be equivalent to 420 gallons per week (630 gal/wk for 1.5 inches). A 1100 gallon cistern, when full, would provide more than two weeks of irrigation water.

Proposed Design and Catchment Layout

Figure 1 below shows how the BPCGSC envisions the layout of the rainwater collection system. The rainwater cistern would be located at the northwest corner of the garden because that corner is at the lowest elevation and allows the entire cistern to be positioned below the grade at the shelter (See Figure 2). Locating the cistern next to the garden will minimize the rainwater collection system's impact to recreational users of the shelter area. However, it will necessitate the use of a buried pipe from the shelter area through the intervening portion of the park and into the garden area. A 3 or 4 inch diameter PVC pipe will be sufficient to convey runoff from the roof to the cistern even during the hardest rainstorms. We propose to bury the pipe on the route indicated in Figure 1. The cistern will be located on a flat base constructed of a wood border and filled with gravel or soil fill.

5"gutters will be installed on both sides of the shelter's roof to maximize the rainwater volume collected. The installation of gutters on the shelter will halt the minor erosion occurring at the drip line of the shelter roof and will facilitate safe walking around the shelter area after rains. The runoff from the gutters will flow into downspouts that will run down the shelter's supporting posts at both the north and northwest corners. A transition from standard downspout to PVC pipe will be made at or somewhat above grade to eliminate leaking at the interface. The cistern will have an overflow that will be directed over some riprap placed behind the garden and directed into the adjacent stream.

Installation Plan

The first step in the installation process will be to build the cistern's base support. This will consist of primarily unskilled labor which will be completed by the garden's volunteer members. Tasks for this step include post hole digging for the 4 x 4's at each corner and possibly at the mid-points. The 4x 4's will hold the wood frame in place and resist outward movement of the fill material. The wood frame can also be built and filled with volunteer labor – though the BPCGSC will have the assistance of a skilled carpenter for guidance. The cistern will be placed on the base support and the necessary plumbing fixtures attached all with garden volunteer labor. The overflow will then be connected and the riprap installed. The next step will be to place the pipe that will convey the roof runoff into the cistern. The pipe trench will be excavated using volunteer labor. Volunteers will use hand shovels to excavate the pipe trench. The grass will be carefully peeled back during excavation so that it can be replaced upon backfilling the trench after the pipe has been placed. If laying the pipe will take more than one day, the pipe will be placed and the trench backfilled the same day to avoid leaving any open trench overnight. These practices will minimize any aesthetic and functional disturbance to the park. After the pipe has been laid the last step will be to install gutters and downspouts on the picnic shelter. This will be done by skilled labor by Leo Gaev Metalworks Inc. which will take care of the liability issues. The Town of Carrboro will add Leo Gaev Metalworks Inc. to their list of approved vendors. No unskilled volunteer labor will be on the roof.

PURPOSE

The Board of Aldermen is asked to receive a report on approaches and logistics of locating a Triangle Transit bus stop along W. Weaver St.

INFORMATION

On November 15, 2011, the Board of Aldermen adopted a resolution directing staff to report on the best approach and logistics for locating a Triangle Transit bus stop on W. Weaver St. Triangle Transit previously provided service to and from Carrboro Plaza in the late 1990s but does not currently serve Carrboro.

Municipal parking lot at 303 W. Weaver St.

The municipal parking lot at 303 W. Weaver St. has a capacity of 33 parking spaces. Carrboro Parking: An Exploratory study, the UNC Dept. of City and Regional Planning study presented to the Board of Aldermen in 2008, reported that this lot's peak usage rate was 11 cars, or a third of its capacity. There is also an uncovered bike rack with 6 bicycle parking spaces. The Town Code [Sec. 6-19(b)(4)(d)] limits parking duration in this lot to not more than two hours, between 7:00 a.m. and 5:30 p.m.

The municipal lot is privately owned. A lease agreement was entered into between the property owners and the Town on July 21, 2004. The lease is exclusively for the Town to operate a municipal parking lot. The lease agreement provides that the Town must receive consent from the property owners for any permanent structural alterations, signs, or additions to the lot.

Potential transit service extensions

Triangle Transit operates local bus service between downtown Chapel Hill/UNC and downtown Durham (400 and 405 routes) and between downtown Chapel Hill/UNC and Research Triangle Park (800 and 805 routes). Triangle Transit operates regional express service between Chapel

Hill and Raleigh (CRX route) to serve weekday commuters. Routes 400 and 800 also operate on abridged schedules on Saturday. Schedules and route maps are shown in *Attachment B*.

To gather information relating to proposed service enhancements for the Draft Bus and Rail Investment Plan in Orange County¹, Town staff and Triangle Transit staff discussed possible alternatives for extending the 405 service into Carrboro during commute times. A hypothetical map is shown below.



Figure 1. Sketch of hypothetical service extension into Carrboro

This map is one way in which a route extension of the 405 could serve downtown Carrboro and specifically the W. Weaver St. lot. Stops are also shown on E. Main St. and E. Weaver St.

Ridership potential

Carrboro has a 16.3 percent transit commute mode split, according to the 2006-2010 American Community Survey, compared to 9.1 percent in 2000. Creating Carrboro's Economic Future, a report commissioned by the Town in 2006, shows that in 2003 a greater percentage of Carrboro residents worked in Durham (27%) than in any other municipality. 2000 census block group data indicate that there is an 8-10% transit commuting mode split in the vicinity of the W. Weaver St. lot. Therefore, a very rough estimate with assumptions based on this work location and mode split data is that the probability of working in Durham and using transit to get to work is 2 to 3 out of every 100 employees. Not all Durham work locations may be near the bus route, however. At the same time, this estimate does not include demand for non-work trips such as school.

Walk access

The table below estimates the walk market for a transit stop at the Weaver St. lot with statistics on residential proximity to the lot. It focuses on the Weaver St. lot only and does not take into account other "downstream" stops that may be added as part of a service extension, such as on E. Weaver St. or E. Main St. Such stops could expand the number of residents who could walk to a transit stop. A quarter- to a half-mile distance is a typical range for measuring walk access to transit stops.

Attachment C shows the stop's $\frac{1}{4}$ and $\frac{1}{2}$ mile network buffers.

Bike access

The table below estimates the cycling market for a transit stop. Bike lanes on W. Weaver St., Jones Ferry Rd., W. Main St., N. Greensboro St., and Fidelity St. - as well as the Frances Shetley and PTA Bike Paths – may be used to access the stop by bicycle, although there is a gap in the bike lane network on the 300-400 blocks of W. Main St., which are currently being explored for a potential road diet. The table uses a two-mile network distance. Two miles is cited as an average, non-recreational bicycle trip length.³ The Federal Transit Administration has a threemile standard for reasonable bicycling distance to transit. However, a bicycle is used for only 2% of all trips 1.6 to 2.8 miles in the U.S.⁴ The statistics exclude addresses in Chapel Hill, as it is assumed for simplicity that transit riders in Chapel Hill would continue to use the existing downtown Chapel Hill/UNC stops. The network analysis uses the street network and does not account for additional access provided by multi-use paths.

Attachment C shows the stop's two-mile network buffer (including Chapel Hill).

Covered bicycle parking may make the transit stop more desirable for bicycle access. Cities such as Charlotte, NC, and Portland, OR, require long-term bicycle parking at park-and-ride lots and require that some or all long-term bicycle parking be covered. Charlotte requires long-term bike parking spaces equivalent to 4% of the number of automobile spaces. Portland requires a minimum of 10 long-term bike parking spaces or five per acre. In Portland, half the long-term spaces must be covered, while in Charlotte, all long-term spaces must be covered. Covered parking can include racks covered by a roof or bike lockers. In Portland, public bike lockers admistered by the city's Bureau of Transportation are available for rent, which varies on the location of the locker. Downtown lockers are \$50 for three months or \$95 for six months, while lockers at transit stations are \$25 for six months.

Feeder bus access

Some residents may access the Triangle Transit stop via a transfer from Chapel Hill Transit. The CW bus stops at 403 W. Weaver St., one block away from the municipal parking lot. The J and F buses also serve the general vicinity. The earliest eastbound CW stops for the E. Weaver St. /Century Center timepoint are 7:35 and 8:05 AM. The earliest eastbound F stops on E. Weaver St. at the Century Center are 7:03 and 7:42 AM. The J stops at 15-minute frequencies between 6:28 and 10:43 AM. at E. Main St. in front of Weaver St. Realty. The number of transfers would likely be affected by how well the feeder bus services would be timed with the express service. Residents can already use these buses to access the 405 in downtown Chapel Hill.

Park-and-ride

A benefit of locating a stop at the 303 W. Weaver St. lot is its potential to serve as a park-andride lot. As noted above, peak demand for this lot is well short of capacity, suggesting that the designation of a certain number of spaces as park-and-ride spaces could occur without impacting parking lot level of service. The Town Code would need to be changed to reflect this designation and allow some cars to be parked for a full day. Some registration mechanism may be advisable to ensure that the spaces are actually used for regional transit riders. If the Town were to pursue a program of installing electric car charging stations in the future, this could serve as a potential station location.

Triangle Transit Short Range Transit Plan

Service expansion to Carrboro is not currently in Triangle Transit's five-year Short Range Transit Plan.⁵ Per a communication with Triagnle Transit staff, the plan is a broad overview and is not necessarily at the level of detail to include every specific route change that could occur in the short term. An extension of the 405 route to Carrboro could improve service in the U.S. 15-501 corridor if it results in additional bus trips. Service improvement in this corridor through coordination with other transit agencies is a recommendation in the SRTP (Ch. 4, Recommendation 4.2.3).

Draft Bus and Rail Investment Plan in Orange County

Improvements to the 405 route have been discussed as a high priority in the Draft Bus and Rail Investment Plan in Orange County.⁶ These discussions have referred to the improvements including an extension of the service into Carrboro. The annual operating cost of these service improvements is estimated to be \$630,000, which would increase annual bus hours by 3,300 and lead to increased frequencies for transit riders in the U.S. 15-501 corridor.

FISCAL AND STAFF IMPACT

No fiscal or staff impacts accrue from receiving the report.
