- 3. Sort items by category show one category at a time starting with first category hide any items not in the category
- 4. Review items within each goal/category consolidate, eliminate duplication, streamline language to focus on outcome or action
- 5. If recommendation is central to the category under review, keep a "1" and change "1s" in other categories to "0" to indicate connection result should be only recommendations central to that specific goal/category
- 6. Review recommendations in each goal/category and assign "1," "2,", or "3" based on degree of priority, e.g., "now, soon, later." This approach will require discussion among board members
- Complete other goals/categories columns confirm goals and priority actions with board – synthesize and summarize a statement of the board's intended policy direction
- 8. Identify required staff action solicit staff feedback and understanding
