## SUMMARY OF APPLICATIONS <u>Planning Board</u>

Candidate's Name: <u>Dana Davis</u> Date of Application: <u>8/30/2012</u>

Candidate Summary: <u>Mr. Davis was appointed to the Planning Board in Fall, 2011, but was unable to serve due to work travel abroad. He is now committed to staying in the area and is currently applying to UNC's Department of City and Regional Planning as he hopes to pursue a career in planning. Mr. Davis has worked on international urban planning and economic development projects in Kosovo, has several years experience in construction, and has served as a member of the Planning Board in Chelsea, MA. He has expressed that he would be excited and honored to be called on again to serve in Carrboro. Mr. Davis has lived in Orange County for 2 years and in Carrboro for 2 years, currently at 1207 W. Main Street. Mr. Davis is 38 years old and self-identifies as white.</u>

Candidate's Name: <u>Jeffrey Miles</u> Date of Application: <u>8/11/2012</u>

Candidate Summary: Mr. Miles is a first-time applicant to Advisory Board membership in Carrboro and would like to be appointed to either the Planning Board or Transportation Advisory Board. He notes that he is interested in helping to guide Carrboro's transportation future, increasing the Town's sustainability, discovering more about the community and becoming more invested in it, and learning about transportation planning. He has taken several classes in general urban planning and transportation planning. He is a prior member of the Chapel Hill Board of Adjustment and wrote his undergraduate thesis on pubic involvement in regional transportation planning. Mr. Miles is employed as a web content manager for the NC Department of Cultural Resources and is a member of OrangePolitics. He was not appointed to either board at that time. Mr. Pickett is retired and notes that he has time to become more involved and has the desire to be helpful. He worked for many years as a builder/developer in Chapel Hill and Carrboro. He has lived in Orange County for 20 years and in Carrboro for two, currently at 108 Sharp Street. Mr. Pickett is 59 years old and self-identifies as white.

Candidate Summary: <u>Ms. Adamson is a first-time applicant to Advisory Board membership in Carrboro.</u> She notes she would like to serve on the Planning Board to give back some of what she has learned about the

planning process as a participant in order to help increase transparency for residents, and to learn more about how planning works at the town level. Ms. Adamson has direct experience with the planning/approval/rezoning process as a resident of the Alabama Avenue neighborhood, including research and public meetings. She also has some work experience with contract review. Ms. Adamson is a finance analyst and a member of NC Women United and the Orange County Beekeepers Association. She has lived in Orange County for eight years and in Carrboro for more than two ½ years, currently at 116 Alabama Avenue. Ms. Adamson is 26 years old and self-identifies as white.

Candidate Summary: <u>Mr. Kuykendall is a first-time applicant to Advisory Board membership in Carrboro. He</u> notes that he would like to apply his knowledge and expertise through service to make a positive and meaningful impact in his community. He has seven years experience in the architecture and design profession and has both a Bachelor of Environmental Design and a Bachelor of Architecture from NC State's College of Design. Mr. Kuykendall works as a consultant and is a LEED accredited professional, a BPI building analyst, and an associate of the American Institute of Architects. He has lived in Orange County for 14 months and in Carrboro for 14 months, currently at 102-B Laurel Avenue. Mr. Kuykendall is 31 years old and self-identifies as white.
