**PURPOSE**

The purpose of this item is to a consider Street Closing Permit Application submitted by the UNC Kidney Center for the temporary closing and usage of streets to accommodate the Kidney Kare 5K Run/Walk on Saturday March 16, 2013 from 8:20 AM to 9:45 AM.

**INFORMATION**

Pursuant to Section 7-19 of the Town Code, a Public Hearing to receive public input prior to issuing a Street Closing Permit is not required for this event. This is the eight year the UNC Kidney Center will be holding this event. The UNC Kidney Center has submitted a Street Closing Permit Application for the temporary closing and usage of the following streets on Saturday, March 17, 2012 from 8:20 AM to 9:45 AM:

1. Start and Finish on McDougle Southeast Drive
2. Right on *Hillsborough Rd* (Stay on Hillsborough Rd through the N Greensboro St split)
3. Right on *High St*
4. Right on *Main St* (stay in bike lane)
5. Right on *James St*
6. Left on *Hillsborough Rd* (stay in bike lane)
7. Left on *McDougle Southeast Drive*

All race proceeds benefit the following UNC Kidney Center programs: UNC Kidney Education Outreach Program (KEOP) and the Carolina Kidney Kids for Pediatric Nephrology. This organization is based in Orange County as required by Section 7-23 of the Town Code.

**FISCAL IMPACT**

Applicant will be responsible for all costs incurred by Police and Public Works to facilitate the events. Applicant will be sent an itemized bill for the final costs incurred by Police and Public Works per event. The applicant has paid the application fee.

**RECOMMENDATION**

Staff recommends that the Board approve the attached resolution for the temporary closing and usage of the following streets in order to accommodate the Kidney Kare 5K Run/Walk under the following stipulations:

1. Applicant shall distribute flyers of notification, to persons occupying property abutting the streets where the event is to take place, of the contents of any resolution passed.
2. Applicant will be responsible for all costs incurred by Police and Public Works to facilitate this event. Applicant will be sent an itemized bill for the final costs incurred by Police and Public Works.
