# A RESOLUTION REQUESTING ONE OR MORE APPOINTMENTS TO THE EXTRATERRITORIAL SEATS ON THE CARRBORO BOARD OF ADJUSTMENT AND PLANNING BOARD

WHEREAS, as a result of a vacancy or the expiration of a term it is necessary to appoint one or more persons to seats reserved on the Carrboro Board of Adjustment and Planning Board for persons residing within the town's extraterritorial planning jurisdiction; and

WHEREAS, by state statute and town ordinance, the Orange County Board of Commissioners initially has the authority and responsibility to appoint extraterritorial members to the town's Board of Adjustment and Planning Board;

NOW, THEREFORE, THE BOARD OF ALDERMEN OF THE TOWN OF CARRBORO RESOLVES:

Section 1. The Orange County Board of Commissioners is respectfully requested to reappoint Margaret Brown to fill the extraterritorial seat on the Carrboro Board of Adjustment whose term extends from April, 1984 to April, 1987. This request is made at this time because the term of the present member holding this seat, Margaret Brown, expired in April, 1984. The requested appointee presently resides at 1509 Smith Level Road, Chapel Hill (within the town's extraterritorial area).

Section 2. The Orange County Board of Commissioners is respectfully requested to appoint Steven L. Chandler to fill the extraterritorial seat on the Carrboro Planning Board whose term extends from January, 1984 to January, 1989. This request is made at this time because the term of the present member holding this seat, Robert McDuffee, expired in January, 1984. The requested appointee presently resides at Route 5, Box 396-F, Chapel Hill (within the town's extraterritorial area).

Section 3. It is further requested that appointments to vacant seats or seats in which the present member continues to hold office pending appointment and qualification of a successor be made effective immediately and appointments to seats in which the terms of city members have not yet expired be made effective on the expiration date of such terms.

Section 4. If the Orange County Board of Commissioners fails to appoint persons willing to serve in the capacity described above within 90 days after receiving this resolution, then the Carrboro Board of Aldermen may make these appointments.

Section 5. The Town Clerk shall send a copy of this resolution to the Orange County Manager. Section 6. This resolution shall become effective upon adoption.

## JOINT PLANNING

At its worksession held on April 18, 1984, the Board of Aldermen requested the Mayor to set up a meeting between the Carrboro Board of Aldermen and the Orange County Board of Commissioners to discuss alternative joint planning arrangements. At this meeting, the Board expressed reservations concerning the most recent proposal. The Mayor requested the Town Attorney to draft an alternative proposal for the Board's consideration. At its worksession held on May 2, 1984, the Board of Aldermen requested that both the agreement proposed by Mayor Porto and the earlier draft be placed on tonight's agenda for discussion prior to the Board's meeting with the Orange County Board of Commissioners.

It was the consensus of the Board to request that the originally proposed jurisdictional line (which extends the present boundary north along the railroad tracks) be adopted north of Eubanks Road, but that the Chapel Hill High School site and the area surrounding the landfill be included within Chapel Hill's jurisdiction. That Orange County be requested to adopt Carrboro's land use ordinance for the ten and twenty year transition areas. In addition, the Board recommends that the town and county agree upon a zoning map for the transition areas using zoning classifications from the Carrboro Land Use Ordinance. It was the consensus of the Board to discuss with the County Commissioners the matter of administrative procedures.
