INTRODUCTION OF BOND ORDERS AND ADOPTION OF RESOLUTIONS PROVIDING FOR PUBLIC HEARINGS ON THE BOND ORDERS

Alderman Hilliard Caldwell introduced the following Order, the title of which was read:

BOND ORDER AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION CAPITAL IMPROVEMENT BONDS (FRANKLIN STREET EXTENSION PROJECT) OF THE TOWN OF CARRBORO FOR THE PURPOSE OF FINANCING, IN PART, THE ACQUISITION OF A RIGHT-OF-WAY AND CONSTRUCTION THEREON FOR AN ADDITIONAL OR IMPROVED CONNECTION OF FRANKLIN STREET WITH THE DOWNTOWN AREA OF CARRBORO, INCLUDING, BUT NOT LIMITED TO, ALL ATTENDANT LANDSCAPING, SIDEWALKS AND RELOCATION OF WATER AND SEWER FACILITIES IN THE TOWN OF CARRBORO

WHEREAS, the Board of Aldermen of the Town of Carrboro (the Board) has decided to pursue the issuance of general obligation bonds in an aggregate principal amount of up to \$700,000 under the Local Government Bond Act (the Act) to finance, in the acquisition of a right-of-way and construction thereon for an additional or improved connection of Franklin Street with the downtown area of Carrboro, including, but not limited to, all attendant landscaping, sidewalks and relocation of water and sewer facilities in the Town of Carrboro; and

WHEREAS, the Board has filed an application with the Local Government Commission of North Carolina for approval of such bonds as required by the Act;

BE IT ORDERED BY THE BOARD OF ALDERMEN FOR THE TOWN OF CARRBORO:

- 1. It is hereby determined necessary and expedient for Town of Carrboro to borrow money, and there are hereby authorized to be issued general obligation bonds of the Town of Carrboro for the purpose of providing money, to finance, in part, the acquisition of a right-of-way and construction thereon for an additional or improved connection of Franklin Street with the downtown area of Carrboro, including, but not limited to, all attendant landscaping, sidewalks and relocation of water and sewer facilities in the Town of Carrboro.
- 2. The bonds shall be in an aggregate principal amount not to exceed \$700,000.
- The bonds shall be general obligations of the Town of Carrboro for the payment of principal of and interest on which its full faith and credit shall be irrevocably pledged

and taxes will be levied in an amount sufficient to pay the principal of and interest on the bonds.

- 4. A sworn statement of debt has been filed with the Town Clerk, pursuant to G.S. Section 159-55 and is open to public inspection.
- 5. This Bond Order will take effect when approved by the voters of the Town of Carrboro pursuant to G.S. Section 159-61.
