## PUBLIC HEARING/ALABAMA AVENUE ASSESSMENT ROLL

This was a public hearing to hear citizens views on the preliminary assessment roll for the Alabama Avenue street paving project.

# REPORT ON HANDICAPPED ACCESSIBILITY

Federal Revenue Sharing regulations require municipalities to make their programs and services available to handicapped individuals. Municipalities must identify program and structural barriers to handicapped individuals through the use of a self-evaluation. Program barriers must be removed by October 17, 1984 and structural barriers must be removed by October 17, 1986. A compliance coordinator is required and a grievance procedure must also be in place no later than October 17, 1986.

Don Casper, Assistant Town Manager, presented a Handicapped Accessibility Report and stated that if it was adopted by the Board, it would bring the Town of Carrboro into compliance with these new regulations.
