## DETERMINATION OF RECOMMENDED CROSS-SECTION OF NC 54

Jim Dunlop, the town's transportation planner, stated that the N.C. Department of Transportation has requested that Carrboro make a recommendation on a desired cross-section of NC 54 when widened so that their design team can proceed on a functional design for the project.

Mr. Dunlop stated that N.C. DOT has proposed two different cross-sections for the widening of NC 54. The first is a five-lane urban section with two 12-foot travel lanes in each direction, and a middle 12-foot dual turn lane. The second is a four-lane boulevard with median. Mr. Dunlop stated that the administration recommended that the Board of Aldermen request that NC 54 be widened to a four-lane boulevard road rather than a five-lane urban section.

Steve Oglesbee, Chair of the Transportation Advisory Board, stated that the Transportation Advisory Board recommended that NC 54 be widened to a four-lane boulevard cross-section with media including a continuous, clearly marked bike lane on both sides and the shoulder treatment varied between a ditch section and curb and gutter, whichever is less disruptive to the surrounding properties at a particular location.

Mayor Porto stated that he would like for the town to encourage N.C. DOT to provide a tree-lined median, rather than concrete.

MOTION WAS MADE BY JOHN BOONE AND SECONDED BY RANDY MARSHALL THAT NC 54 BE WIDENED TO A FOUR-LANE BOULEVARD CROSS-SECTION WITH A LANDSCAPED MEDIAN, INCLUDING A CONTINUOUS, CLEARLY MARKED BIKE LANE ON BOTH SIDES AND THE SHOULDER TREATMENT VARIED BETWEEN A DITCH SECTION AND CURB AND GUTTER, WHICHEVER IS LESS DISRUPTIVE TO THE SURROUNDING PROPERTIES AT A PARTICULAR LOCATION. VOTE: AFFIRMATIVE ALL

It was the consensus of the Board to authorize the Mayor to forward letters to the town's legislative delegation requesting their support for funding of this project.
