PUBLIC HEARINGS SET

(1) Conditional Use Permit Request/Quarterpath Trace

H.J. Gilleece & Associates have applied for a conditional use permit that would permit an architecturally integrated subdivision of 80 lots to be known as Quarterpath Trace. The 27.71-acre parcel is identified as Tax Map 30, Lot 2 and is zoned R-SIR-2. The administration recommended that a public hearing be set for April 26, 1988.

(2) Land Use Ordinance Text Amendment to Raise the Civil Penalty for Land Use Ordinance Violations

ENVIRONMENTAL IMPACT ORDINANCE

At the 1988 Planning Retreat, the Board requested the Town Attorney to modify the Orange County draft environmental impact statement to make it applicable to the Town of Carrboro. The Town Attorney has prepared that ordinance for the Board's consideration.

Mr. Brough explained the proposed ordinance.

MOTION WAS MADE BY FRANCES SHETLEY AND SECONDED BY JUDITH WEGNER THAT THE ORDINANCE BE REFERRED TO THE PLANNING BOARD FOR CONSIDERATION, THAT IT BE RETURNED TO THE BOARD OF ALDERMEN PRIOR TO THE ALDERMEN'S SUMMER VACATION, AND THAT A JOINT WORKSESSION BETWEEN THE BOARD OF ALDERMEN AND PLANNING BOARD BE HELD. VOTE: AFFIRMATIVE ALL

ZONING MAP AMENDMENT TO REZONE R-SIR AND R-SIR-2 PROPERTIES TO R-40 AND THE THE REZONING OF TWO R-SIR PROPERTIES TO R-20

The Board of Aldermen at its meeting of April 5, 1988, requested the staff to revise the proposed ordinance rezoning R-SIR and R-SIR-2 properties to R-10, removing Bolin Forest, Spring Valley, Fairoaks, Highland Hills, The Villages Apartments, Rock Creek Apartments, the Chapel Hill Tennis Club, and the portions of Weatherhill Pointe that are zoned R-SIR. In addition, the Board deleted the P.H. Craig property (Tax Map 30, Lots 2A and 4) from the ordinance adopted on April 5, 1988, which rezoned all R-R properties to R-20 and rezoned the portion of a property zoned R-3 to R-20. The Board requested this rezoning be considered at tonight's meeting.

Ann Weeks, the town's senior planner, briefly explained the proposals for rezoning.

MOTION WAS MADE BY RANDY MARSHALL AND SECONDED BY JUDITH WEGNER THAT THE ORDINANCE ENTITLED, "AN ORDINANCE AMENDING THE CARRBORO ZONING MAP TO REZONE PROPERTIES OR PORTIONS OF PROPERTIES FROM R-SIR (RESIDENTIAL, SUITABLE FOR INTENSIVE RESIDENTIAL) AND R-SIR-2 TO R-10 (RESIDENTIAL, 10,000 SQUARE FOOT MINIMUM LOT SIZE), R-10 BEING THE BASE ZONE OF THE R-SIR AND R-SIR-2 ZONING DISTRICTS, AND THESE PROPERTIES OR PORTIONS OF PROPERTIES BEING ALL THOSE CURRENTLY ZONED R-SIR AND R-SIR-2 WITHIN THE TOWN'S PLANNING JURISDICTION," BE ADOPTED. VOTE: AFFIRMATIVE FIVE, NEGATIVE TWO (CALDWELL, SHETLEY)

PUBLIC HEARING/COMMUNITY DEVELOPMENT BLOCK GRANT APPLICATION

James Harris, the town's community developer coordinator, stated that this was a public hearing to receive citizen comments and suggestions on the 1988 Community Development Block Grant Application. Mr. Harris stated that the town staff had identified two target areas that could be eligible for funding. The first area is the Davie Road area to include the 500-700 blocks of Davie Road as well as all of Neville Road, Bert Street and Colson Street. Twenty-nine homes in this area are in need of rehabilitation--no water and sewer improvements have been identified. The second area, the Roberts Street area, includes Roberts Street and the 700 block of Merritt Mill Road, requiring rehabilitation of ten homes and the replacemnt of four septic tanks with public sewer.

Brodie Edwards, a resident of 504 Davie Road, stated that he was experiencing drainage problems coming from the town's cemetery.

Wilbert Jones, President of the Alabama Avenue/Davie Road Homeowners' Association, spoke in favor of the community development program, but cautioned the Board to have proper supervision of community development projects to assure acceptable improvements.

Catherine Johnson, a resident of Bert Street, spoke in favor of having Bert Street paved.

Braxton Foushee, a resident of 115 Alabama Avenue, spoke in support of both target areas.

MOTION WAS MADE BY RANDY MARSHALL AND SECONDED BY TOM GURGANUS THAT THE PUBLIC HEARING BE CLOSED AS NO ONE ELSE WISHED TO SPEAK. VOTE: AFFIRMATIVE ALL

DISCUSSION OF MOTOR VEHICLE TAX

The administration requested the Board instruct the Town Attorney to prepare an amendment to the Town Code which would eliminate the need to issue vehicle tags and the requirement to display such tags, but to continue the \$5.00 vehicle tax based upon the Orange County tax listing.

MOTION WAS MADE BY TOM GURGANUS AND SECONDED BY JUDITH WEGNER THAT THE TOWN ATTORNEY BE INSTRUCTED TO PREPARE THE REQUESTED AMENDMENT TO THE TOWN CODE FOR THE BOARD'S CONSIDERATION. VOTE: AFFIRMATIVE FIVE, NEGATIVE TWO (MARSHALL, CALDWELL)

SOLID WASTE RECYCLING REPORT

Blair Pollack, Recycling Coordinator for the Town of Chapel Hill, presented a report on the recycling program for Orange County. (See Town Clerk's file of this meeting for a copy of report.)

QUESTIONS FOR OWASA REPRESENTATIVES

The Board was asked to hand in to the town staff any questions to be addressed to the town's representatives on the OWASA Board.

CONSIDERATION OF CANCELING MAY 3RD BOARD MEETING

The administration requested direction from the Board on whether the Board wished to cancel or reschedule the May 3rd Board meeting. This request was made due to May 3rd being election day.

It was the consensus of the Board to have the Agenda Planning Committee consider this matter.

A RESOLUTION REQUESTING ORANGE COUNTY TO ADOPT CARRBORO'S LAND USE ORDINANCE AS PART OF THE JOINT PLANNING AGREEMENT Resolution No. 46/87-88

WHEREAS, Orange County and the Town of Carrboro have signed a Joint Planning Agreement; and

WHEREAS, Section 2.1 of that agreement calls on Orange County to adopt by reference the Carrboro Land Use Ordinance and make its provisions applicable to that portion of the Transition Area located with the Carrboro Joint Development Review Area; and

WHEREAS, Section 2.6.C of that agreement specifies procedures by which subsequent amendments to the Carrboro Land Use Ordinance may be incorporated further by reference by Orange County for application in transition areas.

NOW, THEREFORE, THE BOARD OF ALDERMEN OF THE TOWN OF CARRBORO RESOLVES:

Section 1.
