WHEREAS, the local governments in Orange County have been meeting to discuss issues of mutual interest and concern; and

WHEREAS, the local governments in Orange County have expressed a desire to form an Assembly of Local Governments in order to promote communication and cooperation; and

WHEREAS, a Charter has been prepared by the three Mayors and the Chair of the Board of County Commissioners and has been recommended by them for adoption.

NOW, THEREFORE, THE BOARD OF ALDERMEN OF THE TOWN OF CARRBORO RESOLVES:

Section 1. The Board hereby endorses the Charter for the Orange County Assembly of Local Governments.

Section 2. The Board hereby requests the Mayors of Carrboro, Chapel Hill and Hillsborough along with the Chair of the Orange County Board of Commissioners, to develop and circulate in advance of any meeting of the Orange County Assembly of Local Governments an agenda which addresses new and old business to be considered. And, specifically, that the first agenda address specifically the creation of particular working groups and subjects for on-going information exchange.

Section 3. That the Charter be approved for a two-year period and, unless re-approved, shall expire on December 1, 1990.

RESOLUTION SUPPORTING THE PRESERVATION OF AN OPEN SPACE CORRIDOR IN DURHAM AND ORANGE COUNTIES

Roy Williford, Planning Director, presented a resolution that the Mayors of Durham and Chapel Hill and Commission Chairmen from Durham and Orange Counties were proposing for adoption calling for the preservation of open space extending along the Durham-Orange County line from New Hope Creek to Eno River State Park. Mr. Williford stated that the resolution had been prepared for presentation to each governing board for endorsement of the concept. Mr. Williford stated that the open space corridor would provide a benefit to the urban area, which includes the Town of Carrboro, but is not located within Carrboro's planning jurisdiction. It would seem appropriate for C a r r b o r o

WHEREAS, preservation of open space provides environmental benefits such as protecting water quality and providing habitat for native plant species and wildlife; and

WHEREAS, open space could form an aesthetic link between Durham and Chapel Hill, while allowing the two communities to remain distinct; and

WHEREAS, an open space corridor can serve as a recreational resource providing a place for walking and jogging, becoming part of the regional trail network; and

WHEREAS, as open space corridor can provide opportunity for environmental education and observation of nature. to

NOW, THEREFORE, THE BOARD OF ALDERMEN OF THE TOWN OF CARRBORO RESOLVES:

POST OFFICE PROPERTY ACQUISITION

James Harris, the town's Special Projects Coordinator, stated that the U.S Postal Service was once again advertising for site proposals for a new post office in the Town of Carrboro. Mr. Harris stated that the administration requested authorization for the Town Manager to have a portion of Westwood Cemetery appraised to determine its market value for possible sale to the U.S. Postal Service.

Ben Grantham, a member of the Cemetery Committee, stated that the Cemetery Committee had discussed the sale of a portion of the Westwood Cemetery at its meeting on December 2, 1988, and that the Committee felt that the portion of Westwood Cemetery being considered for sale has been deemed less suitable for burials due to rock formation and outcroppings. The Committee was reluctant to offer more than two acres for sale and requested that the following stipulations be placed upon the sale of the land:

1) That all proceeds from the sale of the land be placed in the Cemetery Fund to be used to replace the property acre-foracre and that any remaining funds be used in accordance with the rules and guidelines set forth for the perpetual fund; and

2) That a public forum be held at some point to discuss how the proceeds from the sell of the land should be used.
