## TOWN COMMONS PROJECT

James Harris, Special Projects Coordinator, stated that as requested by the Board of Aldermen, members of the town staff, Town Attorney, Alderman Bryan and Mayor Kinnaird reviewed the Town Commons Project brochure and have addressed a list of issues that needed resolution before final approval could be given by the Board on the Town Commons Project.

Mr. Harris stated that the administration recommended adoption of a resolution endorsing the construction of the Town Commons Project and approval of the fund-raising brochure for printing.

The following resolution was introduced by Alderman Judith Wegner and duly seconded by Alderman Jay Bryan.

> A RESOLUTION ENDORSING THE CONSTRUCTION OF THE TOWN COMMONS PROJECT Resolution No. 40/88-89

WHEREAS, the Carrboro Board of Aldermen has previously authorized the Town Commons Task Force to solicit contributions necessary to finance the development of schematic drawings for the construction of a Town Commons project; and

WHEREAS, the Board now wishes to formally endorse and authorize the construction of this project, subject to certain conditions and in accordance with the requirements set forth in this resolution.

NOW, THEREFORE, THE BOARD OF ALDERMEN OF THE TOWN OF CARRBORO RESOLVES:

Section 1. The Board endorses and agrees to construct a Town Commons Project subject to and in accordance with the remaining provisions of this resolution.

Section 2. The Town Commons Project shall consist of the following phases:

- Phase I Design phase, including schematic drawings and construction plans and bidding documents
- Phase II Preparation of the Town Commons site (the ball field located adjacent to the Town Hall)
- Phase III Construction or installation of landscaping and park amenities
- Phase IV Construction of the Farmers Market structures
- Phase V Construction of the bandstand
- Phase VI Amenities (Other)

Section 3. This project is intended to be financed solely by voluntary contributions made to, or intergovernmental grants received by, the Town of Carrboro for the specific purpose of constructing a Town Commons Project.

Section 4. No work on any phase of this project shall be commenced until the town has in hand all funds reasonably expected to be required to complete the work on that phase.

Section 5. Work on this project shall proceed according to the phasing order indicated in Section 2, except that construction of the bandstand (Phase V) may begin before construction of the farmers market structures (Phase IV), if sufficient restricted contributions intended solely for the construction of the bandstand are received so that all funds reasonably expected to be required to complete Phase V are in hand before the town has accumulated all the necessary funds for the completion of Phase IV.

Section 6. The town will accept either restricted or unrestricted contributions or grants. Restricted contributions shall be used by the town only to support the phase or phases that the contributor or grantor intended to support. Unrestricted contributions may be used on any phase, but shall be applied as received to each successive phase for purposes of determining whether each phase has been fully funded (and therefore whether construction of that phase may begin).

Section 7. The town shall have in hand all funds reasonably deemed necessary to complete all phases of the Town Commons Project within three years from the effective date of this resolution. If at the end of that period the funds reasonably deemed necessary to complete any of the phases of the project have not been obtained by the town, the town may (i) scale down the unconstructed phases so as to be able to complete construction of the scaled down project with available funds, (ii) extend the fund raising deadline; (iii) seek funding from additional sources; or (iv) consider any other legally available option.

Section 8. This resolution shall become effective upon adoption.
