REQUEST TO SET PUBLIC HEARING/CONDITIONAL USE PERMIT/MEADOW RUN SUBDIVISION

Keith R. Bowman has requested a conditional use permit that would allow Meadow Run Subdivision to be subdivided into 13 single-family house lots. The property is located at the south side of Rogers Road south of its intersection with Eubanks Road and is zoned RR. The parcel is identified as Tax Map 23, Block C, Lot 3.

VOLUNTARY ANNEXATION/WILLOW SPRINGS LONG TERM CARE FACILITY

This property is located at 624 Jones Ferry Road and contains 3.4 acres.

The administration recommended that a public hearing be set for December 19, 1989.

Roy Williford, Planning Director, answered the Board's questions regarding modifications to the plans for the Willow Springs Long Term Care Facility.

PUBLIC HEARING/COMMUNITY NEEDS FOR FISCAL YEAR 1990-91

This was a public hearing to receive citizen input for consideration in the preparation of the FY'90-91 operating budget and capital improvements plan.

Marti Mandell, a resident of Pine Street, requested that a Park and Ride lot be added at Willow Creek Shopping Center, requested an increase in-town bus service from Plantation Plaza to Franklin Street with frequent stops, and requested increased bus scheduling, including year-round service and continued service during holidays and other school breaks.

James Brittian spoke in favor of continued support of JOCCA nutrition program and funding for a Community Center.

Margaret Martin Coski spoke in favor of continued or expanded funding of Orange County Association of Battered Women.

Clark Lohse, Chair of the Cable T.V. Committee, spoke in favor of the Board providing funding for updating the Board Room sound system.

Mayor Kinnaird read a letter from Thorn Kuhl requesting that there be no tax increase in the upcoming budget and pay-as-you-go construction of bike paths.

Mayor Kinnaird read a statement from Heidi Perry, a member of the Transportation Advisory Board, requested that the town purchase of Share the Road signs with funds allocated to TAB in FY'89-90 budget.

Mayor Kinnaird read a statement from Steve Fisher requesting the following in the upcoming budget: (i) that \$25,000 be included for municipal building improvements; (ii) that \$5,000 be allocated for parking and downtown signage; (iii) that funds not be allocated to construct a burn building and smoke house for fire training facility, but use Chapel Hill facilities; (iv) that the purchase of street paving equipment be made sooner and postpone replacement of some firefighting equipment; (v) questioned whether so many police cars are needed; (vi) requested that the budget be increased in order to pave wider sidewalks in central business district in addition to major landscaping; that playground and tot lot design equipment be added to all parks with the reservation of funds for development of nature and environment education facilities in parks; that funds be allocated for non-traditional athletic park facilities; i.e., high jump, broad jump, vault, handball, vault, etc.; (vii) that funds be included for child play/care space in Community Center in addition to a light snack/coffee shop/meeting lounge with an outdoor terrace and garden space; (ix) was opposed to the Pathway Drive Extension to Seawell School Road as a thoroughfare route - this section of Bolin Creek should be preserved as one of the most interesting forest/creek environments

in our area--keep roads out of there. The topography is beautiful-take a walk to that horseshoe bend in the creek; requested Lloyd Street Extension only after study of its impact on intersection with Main Street in central business district; (x) allocate \$45,000 over five years for implementation of selected portions of downtown design guidelines study.

LAND USE ORDINANCE TEXT AMENDMENT/VARIANCES FOR MINOR SETBACKS

Roy Williford, Planning Director, stated that John McCormick, attorney for Mr. and Mrs. Raymond Cashman, had requested an amendment to the Land Use Ordinance which would allow a variance when minor setback violations have been created through a good faith error. Mr. Williford explained the proposed amendment and stated that the administration recommended approval of the proposed amendment.

Mrs. Cashman explained the circumstances that had caused she and her husband to request the proposed amendment.

John McCormick spoke in favor of the proposed amendment.

Allen Spalt questioned how "minor" was defined in the proposed ordinance.

MOTION WAS MADE BY JAY BRYAN AND SECONDED BY TOM GURGANUS THAT THE PUBLIC HEARING BE CLOSED AS NO ONE ELSE WISHED TO SPEAK. VOTE: AFFIRMATIVE ALL

MOTION WAS MADE BY RANDY MARSHALL AND SECONDED BY HILLIARD CALDWELL THAT THE ORDINANCE ENTITLED, "AN ORDINANCE AMENDING ARTICLE V OF CARRBORO LAND USE ORDINANCE (APPEALS, VARIANCES. INTERPRETATIONS) TO AUTHORIZE THE BOARD OF ADJUSTMENT TO GRANT SETBACK VARIANCES WHEN MINOR VIOLATIONS HAVE BEEN CREATED THROUGH GOOD FAITH ERROR", BE ADOPTED, AS AMENDED BY REVISING THE LANGUAGE OF SUBSECTION (1)(B) TO READ AS FOLLOWS: "IF THE APPLICANT IS REQUESTING A MINOR VARIANCE FROM THE BUILDING SETBACK REQUIREMENTS OF SECTION 15-184 AND THE APPLICANT CARRIES HIS BURDEN OF PROVING TO THE BOARD THAT (i) THE NEED FOR THE VARIANCE ARISES OUT OF A GOOD FAITH ERROR, SUCH AS A MISTAKE MADE BY A CONTRACTOR IN LOCATING A BUILDING OR A MISTAKE MADE BY A SURVEYOR IN ESTABLISHING OR IDENTIFYING A PROPERTY LINE, AND (ii) IN THE ABSENCE OF THE VARIANCE THE APPLICANT WILL SUFFER SIGNIFICANT HARDSHIP, AND (iii) THE DEVIATION WILL NOT HAVE AN ADVERSE EFFECT ON THE SURROUNDING PROPERTIES." VOTE: AFFIRMATIVE ALL

ANNUAL REPORTS FROM APPEARANCE COMMISSION, HUMAN SERVICES COMMISSION AND DOWNTOWN DEVELOPMENT COMMISSION

The Board received annual reports from the Appearance Commission and Human Services Commission. The report from the Downtown Development Commission was rescheduled for December 19, 1989.

It was the consensus of the Board to request that the concerns raised by the Appearance Commission regarding how to prevent site plans from being misleading or incomplete, to allow elevation plans to take into account proposed landscaping and grading, to consider requiring a scale model to show scale, and that there be some assurance that the applicant does modifies plans according to the Appearance Commission recommendations be discussed at the Annual Retreat.

REVOLVING LOAN FUND APPLICATION/MUSIC LOFT

James Harris, the town's Special Projects Coordinator, stated that the Music Loft had submitted an application to the town for a \$55,000 loan from the Carrboro Revolving Loan Fund. These funds would be used along with the owner's private funds to purchase and renovate the old Scott Rent-all building at 116 W. Main Street.

Mr. Harris stated that the Carrboro Revolving Loan Fund Review Board had recommended approval of the loan in the amount of \$55,000 for a term of 10 years at 6% interest, contingent upon the applicant satisfying the following requirements: (i) a final, signed, satisfactory purchase agreement; (ii) disbursement of \$100,000 from Village Bank; (iii) final, signed, satisfactory note between Doug Council and borrower in the amount of \$120,000; (iv) all applicable licenses and permits; and (v) that there not be any further debt financing without prior written consent from the Town.

MOTION WAS MADE BY RANDY MARSHALL AND SECONDED BY TOM GURGANUS THAT THE LOAN BE APPROVED AS RECOMMENDED BY THE CARRBORO REVOLVING LOAN FUND REVIEW BOARD. VOTE: AFFIRMATIVE SIX, NEGATIVE ONE (SHETLEY)

APPOINTMENTS TO DOWNTOWN DEVELOPMENT COMMISSION

Gary Phillips, Chair of the Downtown Development Commission, recommended the appointment of Andrew Jones, Sidney Martin and Nancy Ruppert to the Downtown Development Commission.

MOTION WAS MADE BY TOM GURGANUS THAT ANDREW JONES, SIDNEY MARTIN AND NANCY RUPPERT BE APPOINTED TO THE DOWNTOWN DEVELOPMENT COMMISSION. VOTE: AFFIRMATIVE ALL

SLUDGE RELOCATION TO ORANGE COUNTY

Alderman Shetley requested that the town staff check into the newspaper article she had read concerning the relocation of sludge from Durham County to Orange County.

ANIMAL HOSPITAL

Amy Parker, Zoning Development Coordinator, gave a status report on the conditional use permit for the Animal Hospital.

PTA THRIFT SHOP TREE REMOVAL

Mayor Kinnaird requested that the town staff check to see if the trees removed for the PTA Thrift Shop project were in violation of the conditional use permit.
