PROCLAMATION

Alderman Caldwell read a proclamation proclaiming January 21-27, 1990 as Child Safety Week in the Town of Carrboro.

REQUEST TO SET PUBLIC HEARING/LAND USE ORDINANCE TEXT AMENDMENT TO CHANGE THE TIME FOR SELECTION OF BOARD OF ADJUSTMENT OFFICERS

The Board of Adjustment has requested a text amendment to Subsection 15-33(a) of the Land Use Ordinance in order that the terms of officers for the Board of Adjustment will coincide with the terms of appointment to the board.

The administration requested that a public hearing be set for February 20, 1990.

REQUEST TO SET PUBLIC HEARING/MODIFICATIONS TO THE DURHAM-CHAPEL HILL-CARRBORO THOROUGHFARE PLAN

On August 15, 1989, the Board of Aldermen adopted the Durham-Chapel Hill-Carrboro Thoroughfare Plan, except for the deletion of the Homestead Road Extension. The Board also requested that the Alternative Eubanks Road Extension be reviewed by the Transportation Advisory Board and NCDOT for future consideration.

The TAB has considered this matter and recommends that: (i) the Eubanks Road Extension be removed from the Thoroughfare Plan to be replaced by the alternative alignment located outside of the University Lake Watershed, and (ii) the Homestead Road Extension shown as "Alternative B" be considered as an addition to the Thoroughfare Plan at a public hearing.

The administration recommended that the Board of Aldermen set a public hearing for February 6, 1990 on the proposed Homestead Road Extension.

PRESENTATION ON PROPOSED TRIANGLE RAIL SERVICE

Jim Clark, President of Save the Water, made a presentation on the proposed Triangle Rail Service. Mr. Clark stated that the Rail Express would use existing railroad right-of-way in Raleigh and Durham, but Chapel Hill and Carrboro would have to purchase the necessary right-of-way. Mr. Clark distributed a packet of information which contained a resolution adopted by Triangle J Council of Governments supporting the rail service.

RESOLUTION SUPPORTING THE TRIANGLE EXPRESS RAIL PROPOSAL

The following resolution was introduced by Alderman Randy Marshall and duly seconded by Alderman Frances Shetley.

A RESOLUTION SUPPORTING THE PROPOSED TRIANGLE EXPRESS RAIL PROPOSAL Resolution No. 29/89-90

WHEREAS, the Town of Carrboro supports the development and promotion of public transportation to supplement the continued improvement of North Carolina's transportation systems; and

WHEREAS, the town recognizes that the increasingly urbanized and integrated nature of this Region requires regional cooperation in order to provide an adequate and efficient transportation system for Triangle residents; and

WHEREAS, the North Carolina Board of Transportation has approved plans for the development of outer loops for the Raleigh and Durham metropolitan areas; and

WHEREAS, the North Carolina General Assembly acknowledged the need for the development of high occupancy vehicle and mass transportation alternatives such as rail service and allow for NCDOT to spend up to \$5 million from the Highway Trust Fund each year for this purpose.

NOW, THEREFORE, THE BOARD OF ALDERMEN OF THE TOWN OF CARRBORO HEREBY RESOLVES:

Section 1. The Board recommends that the Secretary of Transportation consider the Triangle Express Rail Proposal a reasonable alternative to be studied and evaluated as part of the legally required Environmental Impact Statement on the programmed Raleigh and Durham Outer Loop Projects.

Section 2. The Board recommends that the Triangle J Council of Governments Regional Transportation Authority work together to evaluate the Triangle Express Rail Proposal and Research Triangle Transportation Authority.

Section 3. The Board recommends that the Governor's Rail Passenger Task Force also review this proposal as an integral part of future rail passenger service in North Carolina.

Section 4. The Board recommends the cooperation in the study with the private transportation vendors.

Section 5. This resolution shall become effective upon adoption.

These agreements will allow the town to use a portion of Norfolk Southern's property to construct a bikepath around the Carr Mill Mall property. Mr. Williford stated that the easement will cost the town \$100 per year.
