COMMUNITY CENTER BOND REFERENDUM BROCHURE

Richard Kinney, the Recreation & Parks Director, presented a draft version of a brochure detailing pertinent information regarding the subject of the community center bond referendum. Mr. Kinney asked for further direction from the Board of Aldermen in proceeding with this project.

The Board made revisions to the brochure and requested that it be brought back on September 17th for final approval. In addition, the Board requested that the town staff obtain cost estimates for publishing the brochure in The Chapel Hill Newspaper, Chapel Hill Herald and Village Advocate. Mayor Kinnaird requested that notice of the bond referendum be published in The Village View.

REQUEST FROM TOWN OF CHAPEL HILL AND NEW COVENANT CHRISTIAN CHURCH TO AMEND THE ETJ BOUNDARY

Roy Williford, the town's Planning Director, stated that the New Covenant Christian Church has requested the Town of Chapel Hill to review and approve a land use permit for the construction of housing and a new church on property located northeast of the intersection of Culbreth Road and Smith Level Road. Part of this property is within Carrboro's jurisdiction and part is within's Chapel Hill's jurisdiction.

Mr. Williford stated that the administration recommended that the Board of Aldermen adopt a resolution which would authorize the Mayor to sign a mutual written agreement with the Town of Chapel Hill to adjust the Extraterritorial Jurisdiction line running through the New Covenant Christian Church property to coincide more or less with the center of Smith Level Road.

Alderman Caldwell informed the Board that he is Chair of the Board of Trustees for the New Covenant Christian Church, but that he has no financial interest in the matter at hand; therefore, he stated that he would not be asked to be excused from voting on this matter.

A RESOLUTION OF INTENT TO ENTER INTO A MUTUAL AGREEMENT WITH THE TOWN OF CHAPEL HILL CONCERNING THE EXTRATERRITORIAL JURISDICTION LINE Resolution No. 5/91-92

WHEREAS, the New Covenant Christian Church, as the property owner of Tax Map 122.B.22, requests that the Town of Carrboro and the Town of Chapel Hill adjust the Extraterritorial Jurisdiction line as it affects their property; and

WHEREAS, Section 9-1(b) of the Charter of the Town of Carrboro allows relocation of the division line between the extraterritorial jurisdiction of the Town of Carrboro and the Town of Chapel Hill by mutual written agreement of said municipalities.

NOW, THEREFORE, THE BOARD OF ALDERMEN OF THE TOWN OF CARRBORO HEREBY RESOLVES:

Section 1. The Board indicates its agreement to adjust the Extraterritorial Jurisdiction line on Tax Map 122.B.22 westward to the centerline of Smith Level Road.

Section 2. The Board of Aldermen authorizes the Mayor to sign a mutual written agreement with the Town of Chapel Hill to effect such a change.
