## JUVENILE JUSTICE AND DELINQUENCY PREVENTION GRANT FOR THE ARTSCENTER

# NEW VIEW PUBLICATION COMPANY REVOLVING LOAN APPLICATION

James Harris, the town's Community and Economic Development Officer, state that New View Publication Company had applied for a loan from the Revolving Loan Fund in the amount of \$40,000 to be used for the expansion of the existing business located at 203 W. Weaver Street. Mr. Harris stated that security would consist of a first lien on equipment, inventory and accounts receivable. A third lien would be a deed of trust on the applicant's home of \$19,000. The Downtown Development Commission recommended approval of the \$40,000 loan for three years at 8% interest. # DELIBERATION/VOTE ON THE NEIGHBORHOOD PRESERVATION DISTRICTS

Bill McKenzie, Chair of the Appearance Commission, stated that the Appearance Commission unanimously supports the establishment of the Neighborhood Preservation District as proposed.

The administration recommended adoption of an ordinance designating specific Neighborhood Preservation Districts in the Town of Carrboro and rezoning the properties within the boundaries of the NPD as presented.

MOTION WAS MADE BY JAY BRYAN AND SECONDED BY JACQUELYN GIST THAT THE ORDINANCE ENTITLED, "AN ORDINANCE AMENDING THE CARRBORO ZONING MAP TO CREATE A NEIGHBORHOOD PRESERVATION DISTRICT OVERLAY ZONE ON THE PROPERTIES SHOWN ON THE ACCOMPANYING MAP," BE ADOPTED. VOTE: AFFIRMATIVE FIVE, NEGATIVE TWO (CALDWELL, SHETLEY)

Mike Brough informed the Board that since the town had received a valid petition protesting this rezoning, that this ordinance needed an affirmative vote of three-fourths (6) of the Board's membership to be adopted. Therefore, the ordinance failed to be adopted.

Alderman Gurganus proposed to have the guidelines revised to retain the 90day waiting period for demolition but change the waiting period for other things changed to a shorter waiting period. And, that during the first year, that all problems not mutually resolved between the Appearance Commission/ Neighborhood Preservation District Commission, be brought to the Board of Aldermen for its review.

Alderman Marshall suggested that those Board members who voted against the ordinance bring back a proposal for the Board's consideration.

Alderman Shetley stated that if the Board would set aside time to review an alternative proposed, she would be happy to prepare something for the Board's consideration.

Alderman Marshall stated that he felt the Board would be willing to look at whatever Alderman Shetley proposed.

# <u>RESOLUTION SUPPORTING INSTALLATION OF A TRAFFIC SIGNAL AT THE INTERSECTION OF</u> <u>OLD FAYETTEVILLE ROAD AND JONES FERRY ROAD</u>

The administration recommended adoption of a resolution requesting N.C. DOT to install a traffic signal at the intersection of Old Fayetteville Road and Jones Ferry Road as soon as possible.

The following resolution was introduced by Alderman Frances Shetley and duly seconded by Alderman Hilliard Caldwell.

# A RESOLUTION ENDORSING CARRBORO'S SUPPORT FOR THE INSTALLATION OF AN ACTUATED SIGNAL AT THE INTERSECTION OF JONES FERRY AND OLD FAYETTEVILLE ROAD Resolution No. 25/92-93

WHEREAS, the Town of Carrboro has requested an actuated signal at the intersection of Jones Ferry Road and Old Fayetteville Road within the 1993 - 1994 Transportation Improvement Program, as well as presenting this important subject to the North Carolina Department of Transportation in a resolution on February 12, 1991, as well as on other previous dates; and

WHEREAS, the University of North Carolina Highway Safety Research Center has indicated that there were three traffic accidents at the intersection between November 1, 1990 through October 31, 1992; and

WHEREAS, the North Carolina Department of Transportation Statewide Planning Branch indicates that approximately 10,000 vehicles per day utilize Jones Ferry Road between Old Fayetteville Road and NC 54 Bypass, 8800 vehicles utilize Jones Ferry Road beyond the aforementioned intersection, and 1200 vehicles utilize Old Fayetteville within the area of the aforementioned intersection respectively; and

WHEREAS, a traffic signal is needed to increase the safety for motorists who currently cannot safely negotiate the intersection due to poor visibility resulting from physical constraints such as a blind curve and hill; and

WHEREAS, the correction of the poor site distance through a new roadway design would be cost prohibitive; and

WHEREAS, recent roadway improvements and warning signals have improved the margin of safety, but fall short of providing mechanical traffic control needed to mitigate poor sight distances;

**THEREFORE, BE IT RESOLVED** by the Carrboro Board of Aldermen that the North Carolina Department of Transportation is requested to fully signalize the intersection of Old Fayetteville Road and Jones Ferry Road as soon as possible.
