## CONDITIONAL USE PERMIT MODIFICATION/ARCADIA SUBDIVISION

Roy Williford, Planning Director, stated that the Chapel Hill/Carrboro Co-Housing Association has requested a modification to the conditional use permit for the Arcadia Subdivision that would allow the bridge serving the subdivision to be narrowed from 22 feet to 18 feet. Mr. Williford stated that the Chief Building Inspector determined after a conversation with the N.C. Department of Insurance that Section 602.6.1 of the N.C. Fire Prevention Code (the 20 foot wide unobstructed surface rule) is not applicable to one and two-family units.

## REQUEST FROM PINEY MOUNTAIN SUBDIVISION

The Piney Mountain Homeowners Association is requesting approval of this connection with the City of Durham from the Town of Carrboro, Orange County and the Town of Chapel Hill.

# <u>A RESOLUTION AUTHORIZING EXECUTION OF AN AMENDED AGREEMENT ON REGIONAL ASSISTANCE ARRANGEMENTS FOR WATER SUPPLY EMERGENCIES</u>
