## REQUEST TO SET PUBLIC HEARING/VOLUNTARY ANNEXATION/303 SMITH LEVEL ROAD

# PUBLIC HEARING/LAND USE ORDINANCE TEXT AMENDMENT/ PROVISIONS RELATING TO TOWERS, ANTENNAS, SATELLITE DISHES, AND CABLE TELEVISION FACILITIES

This was a public hearing to receive public comment on a proposed amendment to the land use ordinance provisions relating to towers, antennas, satellite dishes, and cable television facilities.

Mike Brough briefly explained the purpose of the proposed ordinance amendment.

Steve Jackson, founder of the local amateur radio club, asked that the amendment contain provisions for amateur radio antennas.

Gerry Christmas spoke in favor of provisions allowing amateur radio antennas in the proposed ordinance.

Ellen Perry requested that the new communications tower at Town Hall be painted.

Richard Taylor requested that the proposed ordinance be amended to read "communications facility building" rather than "cable television signal distribution center."

Mark Elam with Time Warner, encouraged the Board to speed the proposed ordinance along as quickly as possible in order that they can process their project application.

The Board requested that the Town Attorney amend the proposed ordinance to add provisions dealing with amateur radios and citizen ban radios.

## **BUILDING PERMIT AND LAND USE PERMIT FEE WAIVER POLICY**

Roy Williford, the town's Planning Director, presented the following revised fee waiver policy for the Board's review and consideration:

The Town of Carrboro in its desire to further affordable housing opportunities hereby establishes a Permit Fee Waiver Policy.

"Affordable Housing" is defined as:

- 1. A dwelling unit that can be **purchased** by families or persons with incomes that are less than 80% of the median income for Orange County as reported by the US Dept. of Housing and Urban Development and where the total monthly housing cost (including mortgage payments, utilities, taxes, and insurance) will not exceed 30% of their total monthly income.
- 2. A dwelling unit that can be **rented** by families or persons with incomes that are less than 60% of the median income for Orange County as reported by the US Dept. of Housing and Urban Development and where the total monthly housing cost (including rent payments, utilities, taxes, and insurance) will not exceed 30 % of their total monthly income.
- The Town Manager is authorized to waive land use permit fees(excluding engineering fees) and or building
  permit fees only for affordable housing projects that are being developed on property owned directly or
  indirectly by the Town of Carrboro;
- The Board of Aldermen will consider granting a fee waiver(excluding engineering fees) for affordable housing projects that are <u>not</u> being developed on property owned directly or indirectly by the Town of Carrboro that can clearly demonstrate compliance with the following criteria:
  - 1. The fee waiver will directly benefit families or persons of low to moderate income over a sustained period of time,
  - 2. The project is directly funded by a Federal, State, or Local unit of government specifically to provide low and moderate income opportunities; and
  - 3. The need and benefit will be realized by the community as a whole if the fee waiver is granted.
  - 4. The project would not be affordable but for the granting of a fee waiver.

MOTION WAS MADE BY ALEX ZAFFRON AND SECONDED BY DIANA MCDUFFEE TO ADOPT THE FEE WAIVER POLICY WITH THE FOLLOWING CHANGES AND ADDITIONS:

- a. That the bullet which reads: "The Town Manager is authorized to waive land use permit fees (excluding engineering fees) and or building permit fees only for affordable housing projects that are being developed on property owned directly or indirectly by the Town of Carrboro." be deleted.
- b. That the second bullet be amended to read as follows: "Subject to budgetary constraints, the Board Aldermen may consider granting a fee waiver (excluding engineering fees) for affordable housing projects that are <u>not</u> being developed on property owned directly or indirectly by the Town of Carrboro that can clearly demonstrate compliance with the following criteria:
  - 1. The fee waiver will directly benefit families or persons of low to moderate income over a sustained period of time; and
  - 2. The project is directly funded by a Federal, State, or Local unit of government specifically to provide low and moderate income opportunities; and
  - 3. The need and benefit will be realized by the community as a whole if the fee waiver is granted; and
  - 4. The project would not be affordable but for the granting of a fee waiver; and
  - 5. The project is necessary to implement a component specified in the <u>Consolidated Plan for Housing</u> and <u>Community Development in Orange County</u>, <u>N.C.</u> as required by the HOME program administered through Orange County."

Bulletin board at Carr Court
Items listed in letter from Heidi Perry
Alternative scenarios for purchase of land an capital facility needs

Alderman Anderson requested that the Recreation & Parks Department investigate funding from the Parks Trust Fund.

Alderman Zaffron requested that the town staff investigate funding from private foundations and from Preservation North Carolina to provide funding for improvements to the Town Hall building.

#### **REPORT ON USE OF CITIZEN OPINION POLLS**

The purpose of this item was to provide information on the use of citizen opinion polls as requested by the Board of Aldermen during its 1996 Planning Retreat.

Deywon Arant, the town's Information/Communication Specialist, presented a report on the use of citizen opinion polls. Ms. Arant stated that the following survey methods exist: telephone surveys, direct mail, personal interviews, and focus group discussions. Ms. Arant stated that telephone surveys are considered the best method because they are random, unbiased and can provide scientifically valid data. Ms. Arant stated that the UNC School of Journalism and Mass Communications has conducted a Public Pulse Poll in Carrboro. The last poll was conducted in the spring of 1995 and the next poll is scheduled for the fall of 1997 or spring of 1998. The cost of a telephone survey by a professional outside agency would cost between \$10,000 - \$20,000.

Mayor Nelson suggested tours for citizens at the church, an open house of the current police facilities, tours for press and editorial boards. Prior to tours and public hearing, staff would develop information packet outlining the financing plan. Have a town meeting at the church to receive public input. Finally, the Board would vote on whether to proceed with the purchase of the church.

Alderman Bryan stated that he felt there should be an official public hearing at Town Hall in addition to the town meeting at the church and that the town staff contact the UNC to see if they would be interested in preparing a survey document on this issue.

Aldermen Caldwell and Anderson urged the Board to make sure all segments of the community are included in the process.

Alderman Bryan suggested that this matter be placed on the next Neighborhood Forum agenda to get their feelings on this issue, what they would suggest to get the information to their neighborhoods, and the process in general.

Alderman McDuffee suggested that any groups in addition to the Neighborhood Forum; i.e., churches, be identified to present the proposed process to.

Alderman Gist requested that Board outreach be included in Mayor Nelson's proposed process.

It was the consensus of the Board to approve the process proposed by Mayor Nelson with the Board's suggested additions.

### FUNDING FOR SMALL AREA PLAN FACILITATED MEETINGS

Alderman McDuffee informed the Board that she had prepared letters to send to William Crowther and Mayor Waldorf asking all three governments (Orange County, Carrboro, and Chapel Hill) to share the cost of the Small Area Plan facilitated meetings scheduled for Saturday, April 19th and May 31st. The Steering Committee proposed a formula for sharing the cost which has Orange County and Carrboro sharing equally, i.e., 45% each, and Chapel Hill contributing 10%. The projected cost for the meetings is approximately \$18,000. We are asking the Orange County Commissioners and Carrboro Board of Aldermen each to budget \$8,600 and Chapel Hill Town Council to budget \$1,800.
