PUBLIC HEARING/REVISIONS TO CONNECTOR ROADS POLICY AND LAND USE ORDINANCE

The purpose of this item was for the public to provide comments on the proposed revisions to the town's Connector Roads Policy and Land Use Ordinance.

Neal Mochel, Chair of the Transportation Advisory Board, briefly reviewed the proposed revisions to the Connector Roads Policy.

Richard Ellington, a resident of 109 Bruton Drive, expressed concern about the proposed revision stating that subcollectors, local and minor residential streets shall connect with all surrounding streets. Mr. Ellington state that the proposed amendments should be reworded to give the town leeway in this regard.

Heidi Perry, a resident of James Street, stated that the TAB in writing the revised policy was planning for new streets.

- c. Subsection 15-217(b) should be amended to read: "To the extent practicable, all roads shall be interconnected. Cul-de-sacs are not encouraged unless the topography of the land does not allow a design that would make an interconnecting road practicable.

The Board requested that the Planning Board review Subsection 15-217(h) in the context of the town's residential traffic management plan.

APPROVAL OF INTERLOCAL AGREEMENT/SOLID WASTE MANAGEMENT MATTERS

The Mayor and Board of Aldermen were requested to consider the latest draft of the Interlocal Agreement concerning solid waste matters proposed to be entered into by Orange County, Carrboro, Chapel Hill and Hillsborough.

Attorney Bob Jessup explained the proposed Interlocal Agreement Concerning Solid Waste Management Matters.

REVIEW OF DRAFT FACILITATED SMALL AREA PLAN

The Board of Aldermen will reviewed the <u>Draft Facilitated Small Area Plan</u> submitted by the Facilitated Conference Steering Committee as well as a proposed implementation schedule.

Roy Williford, Planning Director, presented the Draft Facilitated Small Area Plan for the Board's review and consideration. Mr. Williford presented additional comments submitted by Jef and Linda Roberts.

Mr. Williford recommended that the Board ask the Orange County Board of commissioners to set a Joint Public Hearing for the purpose of: (1) amending the Joint Planning Area Land use Plan by adopting the proposed Small Area Plan for Carrboro's Northern Study Area and: (2) amending the Joint Planning Area Land Use Plan and Map to designate Carrboro's Transition Areas I and Ii as Transition Area allowing Suburban Residential areas with housing densities ranging from 1 to 5 units per acre. As an alternative, Mr. Williford recommended that the Board refer the Small Area Plan for Carrboro's Northern Study Area to an ordinance drafting committee to prepare Land Use Ordinance text and map amendments needed to implement the plan which, along with the plan, would be referred, at a later date, to the Joint Planning Amendment process as a package.

Jo Ann Garvin, a resident of Wexford, expressed concern that cul-de-sacs would no longer be allowed within the town's connector roads policy.

PROVISIONAL RECOMMENDATIONS FOR PROTECTING THE CANE CREEK WATER SUPPLY

Representatives from the Orange Water and Sewer Authority presented OWASA'S Provisional Recommendations for Protecting the Cane Creek Water Supply.

Al Reimer stated that the Cane Creek Reservoir is used for fishing, bird watching and canoeing. It currently provides 12 million gallons of water per day. Cane Creek currently has 32 sq. miles draining into the reservoir, 700 families live around the watershed and 4 dairy farms, 60% forest, and the current water conditions are good. Given the current zoning on the watershed, buildout would leave 12% forest, 51% would contain 2-acre residential subdivision. The impact is higher risk of human health problems higher environmental risks, and taste and odor problems in the drinking water, fewer, poor recreation areas, higher treatment costs. Four options for solving the problems: mini lakes, stormwater ponds, large lots, creative open space.

Provisional recommendations

OWASA responsibilities:

- Acquire approximately 1265 acres of additional land;
- Modify water intake structure in the reservoir;
- Evaluate the feasibility of one tributary sub-impoundment; and
- Evaluate water treatment options

Orange County responsibilities:

Modify Cane Creek zoning requirements - large lots or creative open space design.

Orange County/OWASA responsibility:

Seek rezoning in Alamance County portion of the watershed

Orange County/Carrboro/Chapel Hill responsibility:

• Consider transfer development rights opportunities for watershed property owners.



It was the consensus of the Board to schedule an agenda item for late September for the Board to make its final comments on this report. It was the consensus of the Board to submit its comments to the Town Clerk prior to the September 23rd meeting of the Board.

REVOLVING LOAN FUND REQUEST/ACME RESTAURANT

James Harris, the town's Assistant to the Town Manager, stated that Acme Food and Beverage Company submitted a request from the town's Revolving Loan Fund for \$50,000 to operate a full-service restaurant at 110 East Main Street. The restaurant would employ 26 full-time equivalent positions. The Downtown Development Commission and town administration recommended approval of the \$50,000 loan at 7% interest for 10 years.

On March 21, 1997, Wallace Kuralt, a resident of Watters Road, voiced concern that the provisions in the Land Use Ordinance regarding manufactured homes are restrictive and costly. Mr. Kuralt asked that the Board review provisions regarding allowing manufactured homes in Carrboro.

Mike Brough explained the current Land Use Ordinance provisions dealing with manufactured homes.

Wallace Kuralt suggested that the regulations for manufactured homes should be distributed by the town. Mr. Kuralt stated he feels that the masonry foundation is not needed.

Mr. Morgan recommended that the bond not be lowered past the cost of the roof improvements, which is \$4,000.

WHEREAS, the Mayor and Board of Aldermen are aware of the needs within the Town for capital improvements that cannot be met through annual appropriations; and

WHEREAS, the Mayor and Board of Aldermen believe it would be useful to establish a citizen task force to evaluate these long-range needs and alternative sources of financing such capital improvements.

NOW , THEREFORE THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF CARRBORO RESOLVES:

Section 1. A Capital Improvement Task Force is hereby established, composed of twelve members appointed by the Board of Aldermen. All members of the task force shall be residents of the Town. In making appointments to this task force, the Board shall consider including at least two members each from the Planning Board, the Recreation and Parks Commission, the Down town Development Commission, the Neighborhood Forum, the Budget Review Committee and the Transportation Advisory Board. The Board should also appoint two aldermen to participate in the meetings of the task force to act as liaisons with the Board. Staff assistance to the task force shall be provided by the Assistant Town Manager and the Planning Director.

- Section 2. The Capital Improvement Task Force shall: (1) make itself knowledgeable about the Town's current and long-range facility needs; (2) determine possible capital projects for the next ten years; (3) consider the feasibility of the issuance of bonds or other financing methods to address these facility needs; and (4) report its findings and make recommendations to the Board of Aldermen.
- Section 3. The initial meeting of the task force shall be arranged by the Assistant Town Manager. At the initial meeting, the task force shall select a chairperson and establish a meeting schedule to accomplish its assigned tasks by the deadline set in Section 4.
- Section 4. The Capital Improvement Task Force shall make every effort to complete its work and report back to the Mayor and Board of Aldermen by May 15, 1998.
- Section 5. This resolution shall become effective upon adoption.
