<u>PUBLIC HEARING/LAND USE ORDINANCE TEXT AMENDMENT /DRIVE-IN AND DRIVE-THROUGH WINDOWS</u>

The purpose of this item was to receive public comment on a proposed amendment to the Land Use Ordinance which would limit businesses with drive-through windows.

Trish McGuire, the town's Planner, presented the proposed amendment. In addition, Ms. McGuire presented the advisory board recommendations.

Neal Mochel, Chair of the Transportation Advisory Board, stated that the TAB wanted the town staff to look into performance standards for drive-in and drive-through windows. Mr. Mochel stated that the TAB recommended that this public hearing be continued in order to gather this additional information.

Andy Cohen, Chair of the Planning Board, stated that the Planning Board felt this ordinance is too broad. Mr. Cohen stated that there would probably be more support for a prohibitive ordinance in specific areas of town.

Mayor Nelson presented information from the N.C. Air Awareness Campaign listing suggestions for reducing the ozone in the environment. Mayor Nelson stated that parking your car and walking in the restaurant rather than idling at a drive-in window is the first item listed.

Chris VanHessel spoke in support of the drive-through ban. Mr. Vanhessel urged people to park their cars and go inside banks or restaurants rather than waiting at drive-through windows.

Eleanor Ruenna, representing the Sierra Club, stated that fast food restaurants generate more solid waste than sit-down restaurants. Common sense tells us not to idle cars. The Sierra Club supports high density land uses encouraging bikes, pedestrians and public transportation.

Jackie (no last name given) asked that the Board restrict drive-through windows.

Greg Shepard stated that he felt the town should consider prohibiting drive-in windows in zoning districts in addition to B-1(c) Mr. Shepard spoke against disallowing drive-in windows at Carrboro Plaza Shopping Center where there is high traffic volume. Mr. Shepard encouraged the Board to vote on this matter at tonight's meeting.

V.C. Shaw, representing Carrboro Plaza Shopping Center, spoke against disallowing drive-through windows at Carrboro Plaza. Mr. Shaw stated that some businesses require drive-through service-drug stores and dry cleaners. Mr. Shaw stated that there should only one drive-through use at Carrboro Plaza.
