- Review tower ordinance
- > Review advisory board procedures, charges, terms, and appointments, including orientation
- Add gates to ban on subdivision walls
- Review enforcement policies, procedures, personnel to ensure adequate enforcement of land use ordinance, per conditions, erosion control, etc.
- > Institute a procedure to review permit conditions and other commitments to see that they are fulfilled
- > Develop legislative proposals for more equitable taxes (transfer tax, impact tax), inclusionary zoning

Alderman Zaffron presented the following list of items for consideration:

- Study for downtown redevelopment (funding of a charet)
- Funding to complete reserve police force
- Revolving Loan fund for first-time home buyers
- > Analysis of continuation budget for all departments
- > Options for applying surplus fund balance to offset tax increase for 1999-2000

Alderman Caldwell asked that a seasonal holiday committee be established, along with more decorations for the town, and that a directory of home bound senior citizens be established.

Alderman McDuffee asked for cost figures for a modified sidewalk for James Street, not to include curb and gutter. In addition, Alderman McDuffee asked for citizen requests presented at the past two budget public hearings.

# <u>RESOLUTION REQUESTING ACCELERATION OF THE HILLSBOROUGH ROAD WIDENING</u> <u>PROJECT</u>

The following resolution was introduced by Alderman Alex Zaffron and duly seconded by Alderman Allen Spalt.

# A RESOLUTION REQUESTING THE ACCELERATION OF THE CONSTRUCTION SCHEDULE FOR THE WIDENING OF HILLSBOROUGH ROAD AND OLD FAYETTEVILLE ROAD WITHIN THE 1999-2006 STATE TRANSPORTATION IMPROVEMENT PROGRAM Resolution No. 22/98-99

WHEREAS, the Hillsborough Road widening project (recognized by NCDOT as Project U-3100 had been established as a fully funded project as of NCDOT's 1995-2001 State Transportation Improvement Program; and

**WHEREAS**, the Durham-Chapel Hill-Carrboro TAC on January 11, 1995 adopted the Hillsborough Road widening project as the number four priority project within the 1996-2002 Metropolitan Transportation Improvement Program; and

**WHEREAS**, the Town of Carrboro, in cooperation with the Town of Chapel Hill and the Chapel Hill-Carrboro City School Board, adopted resolutions and revised the regional transportation priority list to endorse the acceleration of construction for Hillsborough Road; and

**WHEREAS**, the Mayor of Carrboro and the Durham-Chapel Hill-Carrboro TAC Chair received letters from the North Carolina Board of Transportation on May 12, 1995 stating that the Hillsborough Road project had been accelerated to Federal Fiscal Year 1999; and

WHEREAS, the staff of Carrboro and the staff of NCDOT have been working jointly since February 27, 1996 to the present time to ensure that the roadway's design addresses aesthetic, environmental, and traffic concerns as expressed by the town's citizens; and

**WHEREAS,** on November 20, 1998, officials within the North Carolina Department of Transportation informed the Town of Carrboro that the highway project is now scheduled for construction during Federal Fiscal Year 2001.

# NOW, THEREFORE, THE BOARD OF ALDERMEN OF THE TOWN OF CARRBORO RESOLVES:

Section 1. The Board of Aldermen hereby requests acceleration of the construction schedule for the improvements along Hillsborough Road and Old Fayetteville Road by the North Carolina to Federal Fiscal Year 2000.

Section 2. Copies of this resolution shall be forwarded to the N.C. Board of Transportation, Orange County Legislative Delegation, the Durham-Chapel Hill-Carrboro Transportation Advisory Committee, the Chapel Hill-Carrboro City School Board, and the Chapel Hill Town Council.
