## WORKSESSION/LONG-RANGE PLANNING STRATEGIES

The Mayor and Board of Aldermen identified several long range planning processes at their annual planning retreat in January:

- Millennium Projects
- Vision 2020 process
- Downtown Economic Development Workshop
- Incubator plan to develop information technology industries

The purpose of this item was to allow the Mayor and Board of Aldermen to discuss these four projects in more depth.

#### Downtown Economic Development Workshop

James Harris, the town's Community and Economic Development Director, introduced James Morgan, the Chair of the Downtown Development Commission.

James Morgan, Chair of the Downtown Development Commission, presented a proposal for a long-term vision for Downtown Carrboro. Mr. Morgan suggested that community charettes be held to develop a preliminary vision for the downtown. Mr. Morgan stated that they would like to look at new business opportunities, entertainment and the arts, technology and economic development, needs for existing businesses, walkability, transportation and access, environmental quality and sustainability, quality of the issues, and responsible management of resources.

Alderman Gist suggested that the Downtown Development Commission go hand in hand with the Shaping Orange County Task Force in the visioning process for the downtown.

Alderman McDuffee asked what the Board of Aldermen's role would be in the visioning process for the downtown.

Mr. Morgan stated that a steering committee would be established which would comprise of members from town boards to develop proposals.

Alderman Spalt asked for a specific budget for the visioning project.

Mr. Morgan stated that a budget would be provided at a later date, the current request is for conceptual approval from the Board.

Alderman Broun stated that we need to decide what type of businesses we want in Carrboro, how the town can support the infrastructure and expand the commercial base.

Mayor Nelson stated that the core of the visioning project is very good, suggested that the 2000 T.F. Force needs to be updated.

Rebecca Carnes, owner of Fireplace Additions, and secretary of Carrboro Business Association, stated that there are several businesses in Carrboro that are rapidly growing out of their small facilities. Larger more attractive facilities are needed for these businesses to expand and grow. Ms. Carnes stated that current town policies and plans do not speak specifically to improvements to the downtown. Mr. Carnes stated that none of the members of the Carrboro Business Association are represented in the Shaping Orange County's Future Task Force.

Amy Singleton, a member of the Downtown Development Commission, asked that the Board consider the Downtown Development Commission's request.

#### Vision 2020 Process and Economic Development

Mayor Nelson suggested that the town update the Year 2000 Task Force Policies.

Alderman McDuffee suggested that the downtown visioning process could be a part of this update. Alderman McDuffee suggested that the 2000 be the umbrella.

Alderman Broun requested that the town staff prepare a timeline and process for the 2020 Vision Process.

MOTION WAS MADE BY MICHAEL NELSON AND SECONDED BY ALLEN SPALT THAT THE TOWN STAFF PREPARE A TIMELINE AND PROPOSALS FOR THE 2020 PROCESS, TO INCLUDE ALDERMAN MCDUFFEE'S PROPOSAL FOR ECONOMIC DEVELOPMENT, AND THE PROPOSAL FOR A DOWNTOWN MASTER PLAN. IN ADDITION, THAT THE TOWN STAFF IDENTIFY PROJECT SCOPES AND ASSOCIATED BUDGETS. VOTE: AFFIRMATIVE ALL

#### Millennium Bond Proposal

Mayor Nelson suggested that the town fund a large project for Year 2000 and another large project in Year 2011 to celebrate the town's 100th birthday. In the intervening years, the town would pursue one project each year. Mayor Nelson reviewed a suggested process to include a community brainstorming session, and appointment of a steering committee to narrow the list to 12 projects, develop a funding strategy, and make a
