### PUBLIC HEARING/PROPOSED AMENDMENT TO THE TOWN'S NOISE ORDINANCE

The Board of Aldermen at its meeting on November 28, 2000 set a public hearing for tonight's meeting to receive public comment on proposed amendments to the town's noise ordinance. The Town Attorney has drafted three alternative ordinances for the Board's consideration.

Laurie Flowers, Director of Government Relations with the Chamber of Commerce, expressed concern about the change in the start up time for heavy equipment. Ms. Flowers asked that the Board adopt the town staff's recommendation.

Scott Gardner, District Manager of Duke Power, spoke against the proposed start up time for construction work.

Jerry O'Keeffe, with PSNC, spoke against the proposed change to the start up time.

John Smith, a resident of downtown Carrboro and a Carrboro representative on the OWASA Board, endorsed the town staff's recommendation. Mr. Smith stated that it is OWASA's policy to be a good neighbor and tries to contact residents of neighborhoods where construction will be taking place to inform them of upcoming construction. Mr. Smith stated that if the workday is shortened, the project life and cost will be extended.

Ann Stoddard, a resident of Pathway Drive, expressed concern about the costs to citizens if the workday is shortened. Ms. Stoddard asked that the noise ordinance not be changed.

### MOTION WAS MADE BY JOAL HALL BROUN AND SECONDED BY MARK DOROSIN TO CLOSE THE PUBLIC HEARING AS NO ONE ELSE WISHED TO SPEAK. VOTE: AFFIRMATIVE ALL

Alderman Dorosin suggested that letters be sent to the utility companies that do business in Carrboro informing them of the existence of the town's noise ordinance and that information be distributed on the noise ordinance when building permits are issued.

Alderman Zaffron suggested that utility companies be required to provide information on upcoming projects that will reach homeowners as well as renters.

MOTION WAS MADE BY JACQUELYN GIST AND SECONDED BY MARK DOROSIN TO ADOPT THE ORDINANCE ENTITLED, "AN ORDINANCE AMENDING THE CARRBORO TOWN CODE PROVISIONS RELATING TO THE REGULATION OF CONSTRUCTION NOISE, TO CLARIFY THAT THE NOISE RESTRICTIONS DO NOT APPLY TO WORK WITHIN A PUBLIC STREET RIGHT OF WAY BY A UTILITY, THE TOWN, OR NCDOT. AS AMENDED TO ADD A NEW SECTION 2 TO STATE: "THE SECOND SENTENCE OF SUBSECTION 5-21(B) IS AMENDED TO READ AS FOLLOWS: "A VIOLATION OF THE PROVISIONS OF SECTIONS 5-11, 5-12 AND 5-12.1 SHALL SUBJECT THE OFFENDER TO A CIVIL PENALTY OF TWENTY-FIVE DOLLARS FOR THE FIRST OFFENSE, FIFTY DOLLARS FOR THE SECOND OFFENSE WITHIN A THIRTY-DAY PERIOD, AND ONE HUNDRED DOLLARS FOR THE THIRD OR ANY ADDITIONAL OFFENSE THAT OCCURS WITHIN ANY THIRTY-DAY PERIOD." VOTE: AFFIRMATIVE ALL

The Board requested that copies of the town's noise ordinance be distributed when building permits are issued and that builders post copies on the kiosks at building sites.

# <u>CONTINUATION OF PUBLIC HEARING/LAND USE ORDINANCE TEXT AMENDMENT ASSOCIATED WITH BUILDING HEIGHTS, SETBACKS, AND SIDEWALKS</u>

Proposed amendments to the land use ordinance associated with building heights and setbacks in the downtown were reviewed on December 5, 2000. The Board adopted several amendments, requested additional information, and continued the hearing. The administration recommended that the Board adopt sections 1, 4, 11 and 12 of the draft ordinance and refer the remaining information to the Downtown Visioning Steering Committee for consideration during development of the Downtown Renaissance Plan.

Trish McGuire, the town's Planning Administrator, made the staff presentation.

Marty Mandell, a resident of Pine Street, spoke in favor of Carrboro's small town flavor and urged the Board not to change the appearance of the town.

Faye Farrar, a resident of Prince Street and a member of St. Paul AME Church, introduced Rev. Larnie Horton, Pastor of St. Paul AME Church, spoke in favor of the changes to the building height limitations so that the church could take advantage of the additional height for their new addition.

Giles Blunden spoke in favor of the change in the height restrictions for the B-1(g) zoning district. Mr. Blunden spoke in favor of increasing the intensity of the downtown to increase the tax base.

James Carnahan spoke in support of increasing building height limitations to five stories, conditioned on the downtown charette. Mr. Carnahan pointed out that the *Shaping Orange County's Future Report* stated that density should be focused in the downtown.

Martha Arnold, a resident of Maple Avenue, read a petition asking that the Board postpone any changes to the building height requirements until the downtown visioning process is held.

Susie Holloway, a resident of W. Main Street, expressed concern about raising the height limits on buildings and urged the Board to wait until the downtown visioning process is held before making changes to height limitations

Michael Savino, a resident of Weaver Street, urged the Board to postpone their decision to change the building height limitations.

Rick Palmer, a resident of Carrboro, expressed concern about changing the policy for the benefit of a single development, but stated that he would not be opposed to a three-story building in the downtown, but would be opposed to a five-story building.

Mandy Moneith, a resident of downtown Carrboro, stated that higher buildings are a good idea in downtown Carrboro.

Faye Farrar spoke in favor of commercial space in the downtown and increased building heights.

## MINI-RETREAT: REVIEW OF THE ENVIRONMENTAL ADVISORY BOARD'S RECOMMENDED LAND USE ORDINANCE CHANGES

The Board of Aldermen held a worksession with the Environmental Advisory Board on May 16, 2000 in follow-up to their review of recommended land use ordinance changes. The purpose of the mini-retreat is to provide an opportunity for further discussion of the five issues noted in the staff analysis presented in October 1999.

Glynis Gore stated the EAB was not prepared to make a presentation on Item #1 at this time (Following data compilation and analysis, pursue a watershed-based zoning approach and/or a zoned approach to stream buffers to ensure their effectiveness by specifying permitted used in particular parts of each stream buffer.")

Merrilee Brown addressed Item #2(Using the data noted above and other sources, incorporate biotic communities' overlays that would be used to expand information on, and perhaps re-prioritize, secondary conservation areas that are identified during the site planning/open space designation process.) Ms. Brown stated that the EAB would like to:

- ➤ Initiate a process of cataloging open space in Carrboro
- > Explore methods of land conservation
- ➤ Have a continuing education campaign
- > Establish an EAB resource library

Glynis Gore addressed Item #3 (Develop a manual of open space maintenance procedures and ownership/management responsibilities.) Ms. Gore stated that the EAB would like to develop a pamphlet on managing open space that could be distributed to homeowner associations.

Alderman Dorosin suggested that the brochure include suggestions for use of open space.

Alderman Gist asked that the phrase "passive recreation" be replaced with "low impact recreation".

Giles Blunden addressed Item #4 (Revise parking standard drawings to incorporate a permeable paving system, require a minimum number of compact parking spaces, and incorporate bio-retention areas for water quality protection into parking lot stormwater management systems.)
