TRAFFIC SIGNAL IN FRONT OF BLEEKER BUILDING

Ted Bleeker asked the Town to re-evaluate the decision to put a traffic signal on his property on Main Street. He stated that the placement of this traffic signal on his property will destroy the appearance of his building and will prohibit him from being able to provide a 16-foot handicapped parking space. He suggested that the traffic signal be placed on the opposite side of Main Street.
