# <u>A PUBLIC HEARING TO OBTAIN COMMUNITY INPUT ON TOWN NEEDS AND BUDGET FOR UPCOMING FY06-07</u>

Annually, the Board of Aldermen adopts a budget, effective July 1st- June 30<sup>th</sup> for the Town. The Board, as part of its budget review, schedules a public hearing to receive comments from residents in the community regarding town services. These comments shall be considered in developing the FY2006-07 operating and capital budgets during the budget process.

Robert Dowling, with Orange Community Housing & Land Trust, addressed the Board. He stated that the Land Trust requested \$22,000 from the town for the fiscal year 2006-2007, which is the same amount that was allocated by the Aldermen in the current fiscal year.

Mayor Chilton referred to an email from a Carrboro citizen who is legally blind, stating that there are no audio crossing signals in Carrboro. He asked if there are state or federal funds for that.

Mr. Stewart stated that he had forwarded the email to Dale McKeel, the town's transportation planner, and that the staff needs to identify the intersections.

Mayor Chilton asked if there is an inexpensive, cost-effective way to make the town more accessible to people with wheel chairs.

Mayor Chilton referred to an email from Sharon Cook regarding a bus shelter for the bus stop on Homestead Road, around the corner from Rogers Road. She also mentioned a need for funds to purchase land adjacent to Bolin Creek. She suggested that road repairs and maintenance are priorities.

Mayor Chilton mentioned the possibility of combining fire services between the towns of Carrboro and Chapel Hill. Being that we are soliciting applications for a new fire chief, it is important to swiftly get to the point of stating clearly if this is something we need to explore. He suggested that staff bring the Board a short memo outlining what they see as the potential benefits and problems.

Alderman Broun stated that she wants more than a two or three page memo to be discussed during the budget process. She said that she thought we would be doing the citizens a disservice if we do not look at it closely.

Alderman Haven-O'Donnell said that folks see this as a fire response issue and that it is not just a matter of combining services. She suggested a very detailed report.

Alderman Coleman said the short-term question is whether we put the hiring of a fire chief on hold while we explore the question of merging the two departments.

Mayor Chilton said that if this holds a significant amount of promise financially, that we ought to be pursuing it. He does not want to drag out the discussion while hiring a new fire chief.

Alderman Herrera said that he wants to continue looking at ways to save tax dollars but it is dangerous and bad for moral for the Carrboro Fire Department to be missing the head of their team. He wants our fire chief to be part of the fire department and to find the best fire chief as soon as possible. He asked for details of transitions in other towns.

Alderman Broun said that it is a big issue and we need to have more information. Even if we hire a fire chief, we may decide to merge the fire departments. We should proceed with hiring a new fire chief.

Alderman Gist said that twelve years ago, or more, this issue came up. We have a merged bus and school system. Our fire and police departments are very cooperative with each other. She is in favor of getting as many facts as we can to make a decision. We may not have to merge but there are some things we could do together. The last time we found out that it did not save money.

Alderman Gist asked for three board members and a staff member to come up with a list of questions in order to move on with a decision.

Mayor Chilton said that if staff thinks it will save \$10,000, it is not a sum that is worth pursuing. If there are implications about whether a \$1.8 million fire station was really needed, it is worth considering. If it holds any promise to involve numbers like that, it is worth spending more time on. He asked staff for a written reaction. If it appears that this concept holds much potential, we can put it on a future agenda, and if it does not seem that promising, we can drop it.

Mr. Stewart said he is still unclear about moving forward and recruiting a fire chief. He stated his concern that there are good applicants who will not risk current jobs for something that might disappear in six months. The town staff wants to give the Board something meaningful and will move as quickly as possible.

Mayor Chilton stated that Nerys Levy requested \$500 for the Community Dinner.

Alderman Coleman asked for a short status report about the Bolin Forest Homeowner's Association letter. What is going on with the Adams Tract?

Alderman Herrera said that some people he works with do not understand English or have email and asked if there is a way to get interns/students/Americorps to host a forum where we invite the community to give their feedback. You cannot contribute much if you do not understand what is being said. Do we have an accessibility policy?

Mr. Stewart said that it depends on what you mean by accessibility. If it is physical, the Town complies with the Americans With Disabilities Act to make sure we meet the requirements. We can explore how to reach out but we cannot anticipate every need that someone has if they do not express it. We need to help folks find ways to express it.

Alderman Herrera asked if a summary of key budget issues could be posted in Spanish on the town's website.

Alderman Haven O'Donnell asked if he was asking for headphone translators at Board meetings.

Alderman Herrera said if we purchase that equipment, it is a good investment for charettes and key meetings. It might be a good investment to hire somebody - an interpreter. That way you get a large amount of folks who otherwise would not have access.

Alderman Gist said that if we have meetings like that, we can get more help than we need with student volunteers who would come in and act as interpreters.

Alderman Herrera said that last week, at transit forum, there was not a single Spanish speaking person there. They are the ones who use the busses. They could not come to a night meeting where there is no childcare.

Alderman Broun said that when we look at the budget, we need to think how it is intertwined with other things and if it brings in tax revenue.

Ellen Perry addressed the Board. She asked if there was something that could be located near the exit sign by the front entrance to the Town Hall that would blink to alert people inside that someone outside needed to come in.

Alderman Gist asked about reinstating a Youth Town Hall Day, which was a program where high school kids learned how the town functioned.

## CONTINUATION OF A PUBLIC HEARING ON LAND USE ORDINANCE TEXT AMENDMENTS TO ESTABLISH ARCHITECTURAL STANDARDS FOR DOWNTOWN CARRBORO

The Board of Aldermen held a public hearing on January 24, 2006 and received public comments on a draft ordinance that establishes architectural standards for the downtown. The Board of Aldermen continued the hearing to allow additional time for consideration of the draft ordinance.

Trish McGuire, the town's Planning Administrator, addressed the Board.

Alderman Broun proposed creating a subcommittee with architects and members of the Planning Board and Appearance Commission to develop a group of standards that are performance based.

Alderman Coleman said he is intrigued by the suggestion made by James Carnahan about revising the burden of proof for the CUP. He would like to see staff comment on the workability of this proposal.

Mayor Chilton expressed concern about a grocery store project where Mellott Contracting is now. It could be done well or poorly from an aesthetic point.

Mayor Chilton said that a few items strike him as very important and we ought to be proscriptive. A ground floor exclusively for parking is a bad idea. He does not want to completely adopt or shelve what we have in front of us. He asked that the Planning Board and/or some knowledgeable people to go through this and keep the good points – even if they cut out 80-90% of what is there.

Alderman Broun said that she is not opposed to that, but as of now, she cannot support it. She wants more commercial and not more expensive condos.

Bob Kirschner addressed the Board. He asked for a summary of James Carnahan's email.

James Carnahan addressed the Board to summarize his email.

Mayor Chilton stated that the Board should consider looking at the Table of Permissible Uses and types of permits for land uses. Our ordinance would allow an Advance Auto to open with a zoning compliance permit and permission from staff, but in the same zoning district, a childcare center would require someone to come before the Board and it would take 12-18 months. It does not make any sense at all.

Mike Brough said that he would check and find out.

Mayor Chilton asked that a letter be written to the school board, asking them to submit a name for the Recreation and Parks Commission.
