PRESENTATION OF 2006 CARRBORO MOBILITY REPORT CARD

A Mobility Report Card has been prepared for the Town of Carrboro. Michael Hallock-Solomon of LSA Associates, Inc. presented a summary of the report.

Michael Hallock - Solomon, of LSA Associates Inc., made a presentation to the Board.

Alderman Haven O'Donnell stated that she was surprised that there were no significant changes in congestion in the Homestead/Rogers Road corridor because of schools and neighborhoods coming in and that there was only an addition of one bikeway.

Michael Hallock – Solomon stated that a lot has been done since 2005.

Alderman Herrera stated that NCDOT needs to be aware that a light or crossing path is needed at the Davie/ Jones Ferry Road intersection across from Abbey Court because it is very dangerous and accidents have increased in the two years of study.

PUBLIC HEARING: LAND USE ORDINANCE TEXT AMENDMENT TO REVISE PROVISIONS RELATED TO CHILD DAY CARE HOMES AND FACILITIES

The purpose of this item was to receive citizens' comments regarding a request to amend the text of the Land Use Ordinance to revise several current restrictions on child day care homes and facilities, and to consider the adoption of an ordinance which responds to the request and proposed revised definitions.

Kendal Brown, the Planner/Zoning Development Specialist, made a presentation to the Board.

Mayor Chilton stated that smaller day cares were given more scrutiny than larger ones and the special use permit process takes too long. The staff recommendation clarifies the process but does not simplify the process to get them approved. Under our current ordinances it is difficult to open a new daycare facility. He stated that he is concerned about regulations protecting neighbors, but more concerned about driving the business out of our town and at the same time creating more of a demand.

Alderman Broun stated that she would like to see more of an incentive bonus for new commercial developments. She noted that the regulations are just about zoning and not what is going on inside the daycare.

Alderman Gist encouraged residential developers to find ways to encourage clubhouses to be used as childcare centers. It would create jobs, keeps kids safe, and cut down on transportation problems.

Alderman Haven O'Donnell stated that she supports the incentive to create day cares in new developments. Parents have to take their children to day care outside of their own community and it is important to have their children community centered.

<u>PUBLIC HEARING: LAND USE ORDINANCE TEXT AMENDMENT TO REMOVE THE</u> MANSARD ROOF OPTION FOR THE NEIGHBORHOOD PROTECTION OVERLAY DISTRICT

While considering a request from the Planning Board to remove the opposite side stepback provision, the Board of Aldermen scheduled a public hearing to receive comments on removing the mansard option associated with the third story of buildings in the Downtown Neighborhood Protection overlay district.

Trish McGuire, the town's Planning Administrator, addressed the Board.

Eleanor Kinnaird, a member of the Economic Sustainability Commission, addressed the Board on behalf of the chair and as a citizen who is interested in architecture and what happens visually in our town visually. She stated that ESC felt it was an interesting solution because it masks greater height, gets around the ordinance, softens the difference between those two areas, and is an interesting architectural feature. They want to avoid looking too uniform and "plug-in" which is not "Carrboroish". When we encourage architectural design and creativity to make that transition, we have a more interesting streetscape. She encouraged the Board not to delete the mansard roof.

Mayor Chilton stated that the proposed change does not affect whether or not a person can build a mansard roof in our town. It would be permissible. The question is whether the mansard roof line should count as the ten foot stepback that the ordinance requires. If it requires a ten foot stepback, there should be an actual ten-foot stepback rather than a modified roofline.

Alderman Zaffron said the language was drafted expressly to create an option for creating a greater amount of square footage.

Alderman Haven-O'Donnell asked if stepbacks will be staggered if things stay the way they are and we accept proposal. There is a funny ledge on one side because of the right-of-way on the 3rd floor that is weird and constraining for architects.

Mayor Chilton stated that he liked Alderman Zaffron's suggestion.

Alderman Zaffron stated that we adopt the language deleting the reference to mansard roof options to the DMP overlay alone.

Mayor Chilton stated that there would be no mansard roof within the 50 foot buffer.

Blan Hollman, a Carrboro citizen, addressed the board. He asked why mansard and not gambrel roofs.

Alderman Broun stated that mansard roof and gambrel roofs, like cars, are not all the same. Carrboro does not have a standard architecture and it is wrong to impose one. She stated that the Board may want to show people different mansard and gambrel roofs if they can be found locally.

<u>PUBLIC HEARING: LAND USE ORDINANCE TEXT AMENDMENT TO REVISE THE</u> <u>DOWNTOWN NEIGHBORHOOD PROTECTION OVERLAY DISTRICT OPPOSITE SIDE</u> <u>SETBACK PROVISION</u>

In response to a request from the Planning Board, the Board of Aldermen scheduled a public hearing to receive comments on one of the stepback requirements associated with the Downtown Neighborhood Protection overlay district.

Trish McGuire, the Planning Administrator, addressed the Board.

Alderman Zaffron stated that there is a remedy to a technical error.

Alderman Broun stated that she does not want to tamper so much with downtown so we have to re-evaluate whether we will ever get to the long-term goal. We have to do this or it will be unlivable for middle class. We have to define it to mean what we say it means. It is not a condominium.

David Ripperton addressed the Board. He stated that he was in favor of adopting the recommendation. Stepbacks make it more expensive because you need transfer beams.

James Carnahan, Chair of the Planning Board, addressed the Board. He stated that since you step back ten feet, for every ten lineal feet, you give up 100 square feet of usable space. With two stories, you lose enough space for one employee. He stated that the Planning Board was recommending approval of the amendment.
