## PUBLIC HEARING ON FY 2008-09 MANAGER'S RECOMMENDED BUDGET

The Board of Aldermen, prior to adopting the budget, is required by G.S. 159-15 (b) to schedule a public hearing. The public hearing is designed to receive community input on the Manager's recommended budget for the upcoming fiscal year. Following the budget hearing, the Board was requested to provide direction to the Town Manager for the June 3<sup>rd</sup> meeting, including preparations for the final budget and a work session agenda, if desired.

Mike Maher with Wootini, expressed his desire for the town to promote town and arts events, and encouraged the establishment of a planning and promotions committee.

Zach Ward with DSI Comedy Theatre spoke about the positive impact his business has on town economics, expressed the need for town involvement in advertising arts-related events, and spoke in favor of town providing staff to focus on promoting the arts.

Robert Dowling, Executive Director of the Orange Community Housing and Land Trust, spoke in support of the Land Trust's increased funding request.

Marty Mandell suggested that Mike Maher and Zach Ward contact the Chapel Hill/Orange County Visitors Bureau about promoting arts events, spoke in opposition to the proposed tax increase, stated that she feels the Schools Adequate Public Facilities Ordinance is not working and feels the word "district" should be changed to "appropriate school", the land transfer tax would likely pass if the buyer, rather than the seller, would have to pay the tax, and feels the school and government bureaucracy is out of control.

Alderman Gist expressed her desire to see the school system go to year round schools.

Alderman Broun stated that all elected officials in Orange County need to focus on commercial growth.

Mr. Stewart suggested that the Local Living Economy Task Force discuss support for the arts.
