JORDAN LAKE WATER SUPPLY ALLOCATION

At the March 31, 2008 Assembly of Governments meeting, OWASA presented its intent to update the long term water supply plan to consider a new intake from Jordan Lake. The purpose of this agenda item was to receive a presentation from the NC Division of Water Resources regarding the allocation of drinking water from Jordan Lake to help inform the Town's evaluation of long term water supply planning.

John Morris, Director of the N.C. Department of Water Resources, gave a history of the creation of Jordan Lake and stated that there is currently one intake area on the east side that current agencies receiving allocations, with another site identified on the west side.

Ed Kerwin, Executive Director of the Orange Water and Sewer Authority, addressed how OWASA customers would receive Jordan Lake water if needed. He stated that OWASA would buy treated water from the City of Durham. He stated that OWASA would like to keep the option of using Jordan Lake water open, although it is not anticipated that that allocation will be needed. He stated that it is his understanding that the City of Durham will have a daily need for Jordan Lake water in the near future.

Alderman Coleman suggested that discussions be held by local governments and OWASA about growth plans before any decisions are made regarding Jordan Lake. In addition, he asked about the University's rights to alternate sources of water under their agreement with OWASA. He asked if this is negotiable.

Mike Brough stated that he would review the water sale agreement.

Mayor Chilton stated that he hoped that Pittsboro will participate in Jordan Lake discussions.
