<u>A PUBLIC HEARING TO OBTAIN COMMUNITY INPUT ON TOWN NEEDS AND BUDGET FOR</u> <u>UPCOMING FY2010-11 (ITEM A(1)</u>

Annually, the Board of Aldermen adopts a budget, effective July 1- June 30th for the Town. The Board, as part of its budget review, schedules a public hearing to receive comments from residents in the community regarding town services. These comments shall be considered in developing the FY2010-11 operating and capital budgets during the budget process.

Mr. Stewart commented on the actions for the 2009-10 budget, the current year revenues and projections for the 2010-11 budget, and projected expenditures for 2010-11.

Ellen Perry asked for the Board's support in maintaining case management for people with disabilities.

Alderman Gist stated that the Board would discuss this matter with the legislative delegation at the legislative breakfast.

Robert Dowling with the Community Home Trust, asked for \$34,000 in the FY2010-11 budget.

A draft ordinance that makes changes to the income limit and proportion of affordable units was prepared in follow-up to a request from Robert Dowling of the Community Home Trust. Staff has begun meeting with builders, developers, and affordable housing providers. Additional time is needed to develop a refined strategy related to income limits and inclusion of units in development projects.
