A worksession of the Carrboro Board of Aldermen was held on Tuesday, November 9, 2010 in the Board Room of the Carrboro Town Hall.

<u>COURTESY REVIEW OF 201 NORTH GREENSBORO STREET AREA AND POLICIES</u> <u>POTENTIALLY AFFECTING A DEVELOPMENT PROJECT</u>

A potential applicant for a development project at 201 N. Greensboro Street requested an opportunity to discuss policy issues surrounding the potential application with the Board of Aldermen. Town staff requested that the Board conduct a courtesy review of the information and, where appropriate, offer comments related to policy matters.

Michael Brough, the Town's Attorney, highlighted that there is not a request to rezone nor develop the property at this time. He noted that the development of this property would require certain planning and zoning considerations but this meeting was not for a detailed site review.

Chris Bostic, a professional engineer with Kimley-Horne and Associates, stated that he represents the interested developer, Hart Red. He explained that they are seeking further information on what may be allowed at the site and stated that they have spent an extensive amount of time reviewing the Town's Development Ordinance and Town Visioning documents. The next step will most likely take place in January and include conversations and meetings with neighboring property owners in that area. He presented the Board with preliminary schematic plans. He explained that a two-story building is the only economically viable option at this point. The proposed building would be 24,000 square feet. It is the developer's intent to have a single-tenant bottom floor with additional tenants on the top floor. He explained that the developer understands that ease of pedestrian flow is a top priority of the Town and they would consider upgrading the pedestrian traffic flows. At this time, the developer does not own any of the properties but is in the beginning phases of forming a contract for purchase. The current sidewalk design is between 10 feet and 12 feet.

Alderman Coleman encouraged Mr. Bostic to meet with James Harris, the Town's Economic Development Director, in planning the development. He explained that currently, a lot of Carrboro business owners are looking for space to open or expand and that this building could offer that space. He stated that Center Street will need limited traffic because of the residential neighborhood and the historic fabric of downtown Carrboro. He also suggested that the applicant apply for Conditional Use Rezoning, if rezoning is considered, to allow the community to weigh-in on the project. He encouraged the applicant to closely review and consider the Downtown Livability Amenities during the design phase. Alderman Lavelle noted that the applicant should be aware of the Planning Board's green building "checklist" that is used when reviewing proposed projects.

Mayor Chilton suggested relocating the proposed entrance directly across from the Harris Teeter entrance so a four-way intersection is created. He also suggested that the applicant consider abandoning or limiting the public right-of-way on Short Street. If Short Street access is closed or limited, there would also need to be a driveway access agreement with Fitch Lumber Company because they would need access across the property.

Alderman Slade stated that if homes have to be removed, he encourages their relocation rather than being destroyed and placed in the landfill. He also suggested the expansion of sidewalks, bicycle paths and pedestrian access along the property, a naturally vegetated buffer screen between Center Street and the property, and the reduction of "heat islands" or paved surfaces.

Alderman Haven-O'Donnell stated that she supports the idea of flexible business space on the second level of the property. She stated that she agrees with the suggestion of creating a limited right-of-way on Center Street so that the residential character of the area may be maintained. She suggested that the applicant closely review and consider the ideas presented during the Weaver Street charette on the use of the property.

Alderman Gist stated that a 24-hour facility would not be appropriate in that area and that the applicant should also consider delivery times, parking lot lighting, and other relevant considerations related to the tenant's impact on the quality of life of neighbors.

Alderman Broun stated that one of her concerns is dealing with the possibility of this project causing a vacancy in another location in Town.

UPDATE ON BOLIN CREEK WATERSHED RESTORATION ACTIVITIES

The purpose of this agenda item is to provide an update on the status of Bolin Creek watershed restoration efforts.

Randy Dodd, the Town's Environmental Planner, made the presentation. The project is funded by the Environmental Protection Agency through the State of North Carolina and the project cost may be near \$100,000. The project is scheduled to start after Thanksgiving and be completed in January.
