AMENDMENT TO THE WATER AND SEWER MANAGEMENT, PLANNING, AND BOUNDARY AGREEMENT

The purpose of this agenda item was to provide the Board of Aldermen with a resolution authorizing changes requested by OWASA, Orange County, and Hillsborough to clarify the Water and Sewer Management, Planning, and Boundary Agreement (WASMPBA).

Alderman Coleman stated that he spoke with the Chair of the County Commissioners and it was requested that the County is included in any resolution that the Board may pass.

Gordon Merklein, Chair, of the OWASA Board of Directors, made the presentation. He explained that current language in the 2001 agreement may be interpreted as constraining access to Jordan Lake water supply allocations. The OWASA Board requested that the language be amended to protect OWASA's five million

gallons/day allocation. The requested change has been approved by the Towns of Hillsborough and Chapel Hill. Mr. Merklein stated that the resolution is supported by the staff members of Carrboro, Chapel Hill, Hillsborough and Orange County. He also explained that the resolution is also supported by the Chamber of Commerce and UNC Chancellor Holden Thorp.

Steve Stewart, Town Manager, commented that Town Staff have not announced full support of the amendment.

Mayor Chilton explained that he is not concerned with the Hillsborough or Orange County water supply plans. He explained that he understands that all parties are attempting to do the best thing for the community. He respects OWASA's professional opinions but disagrees with the amendment. He feels the current water conservation efforts have proven to be more effective than anyone would have believed ten years ago and that the community can live with the current water levels. He explained that he does not feel that Jordan Lake water supply is needed at this time. He also stated that the quality of Jordan Lake water is much lower than what is currently available to Carrboro and includes numerous pollutants. Mayor Chilton stated that he does not support the use of Jordan Lake for water in the future. He stated that this item is directly related to the Rural Buffer because there are two factors that define the limits to urban growth for the Chapel Hill-Carrboro Area: 1) the Rural Buffer; and, 2) the available water supply. He wants to see the area grow in a way that is sustainable for the community's water supply.

Alderman Gist stated that one of her first votes as an Alderman involved protecting the University Lake Watershed. The community has taken many steps and sacrifices to protect current water supplies to that Jordan Lake water does not have to be used. She also stated that OWASA plays a role in the planning and zoning of the Town of Carrboro and that by arguing for the use of Jordan Lake, it seems to undermine OWASA's involvement.

Alderman Coleman stated that he agrees with Mayor Chilton's and Alderman Gist's comments. If the Town's current Land Use Planning threatens the sustainability of the locally sustained water supply it should be examined to determine if it is growth, or the staging of growth between now and the availability of the quarry that is threatening. He suggested a joint discussion with the Town of Chapel Hill to determine proper growth limits within Carrboro and Chapel Hill. This item was discussed by the Town of Chapel Hill and there is a feeling that it was not properly deliberated. He stated that the positions that the Board take tonight may help inform the Town of Chapel Hill if this item is brought back to one of their future meetings.

MOTION WAS MADE BY ALDERMAN COLEMAN AND SECONDED BY ALDERMAN HAVEN-O'DONNELL THAT THE WATER AND SEWER MANAGEMENT, PLANNING, AND BOUNDARY AGREEMENT (WASMPBA) BE CLARIFIED WITH THE ADDITION OF THE FOLLOWING LANGUAGE AS A NEW SUBSECTION 3 TO SECTION VII.A (EMERGENCY WATER TRANSFERS), AND THAT SAID LANGUAGE ALSO BE ADDED TO THE EXISTING TEXT OF SECTION VII.B (NON-EMERGENCY WATER TRANSFERS): "THE PROVISIONS IN THIS SUBSECTION DO NOT APPLY TO THE TREATMENT OF AND TRANSFER OF WATER AVAILABLE THROUGH HILLSBOROUGH'S OR ORANGE COUNTY'S JORDAN LAKE WATER SUPPLY STORAGE ALLOCATIONS FOR USE BY HILLSBOROUGH OR ORANGE COUNTY CUSTOMERS. NOTHING HEREIN SHALL BE CONSTRUED TO PREVENT HILLSBOROUGH OR ORANGE COUNTY FROM ENTERING INTO AGREEMENTS AS NECESSARY TO PROVIDE FOR WATER TRANSFERS TO AFFORD HILLSBOROUGH OR ORANGE COUNTY ACCESS TO THEIR RESPECTIVE JORDAN LAKE ALLOCATION." VOTE: AYES SIX, NOES ONE (BROUN).

Alderman Slade also expressed his support of the previous comments of the Alderman. He stated that New York City recently compared the cost of cleaning a water supply verses maintaining a clean water supply and that it is much more cost effective to keep the water supply clean. He suggested that it would be helpful to have figures that compare the Town of Carrboro's water use efficiency with other jurisdictions that will be pulling from Jordan Lake. He also explained that although Jordan Lake is identified as the second best source water alternative after the quarry, that in reality, water conservation restrictions are the next best alternative.

Alderman Broun stated that she sees Jordan Lake as an emergency access to water during times of very limited access to water usage. She does not see the access to Jordan Lake as a replacement of University Lake, Cane Creek, or the quarry but rather as in insurance policy. She thinks that it would allow the Town a method of intake control that is currently not guaranteed. Currently, there is no infrastructure available that would allow direct access to the water. The Town's only access is through Cary. She also requested that when comments are received from other Boards that a memo be sent so that all Board of Aldermen members would have access to the information. She stated that when you discuss growth limits that the cost of water, availability of water, and the rural buffer should all be considered.

Ed Holland, the OWASA Planning Director, stated that the only access to Jordan Lake water is through Durham. The current Level-2 allocation reserves a portion of Jordan Lake for future use but the only way that water is available is through Durham and Cary. There are existing agreements for a short-term purchase from Cary and Durham but the current Level-2 allocation does not allow OWASA direct access to the water. There are no agreements in place that address long-term access. The conversion from Level-2 to Level-1 would require OWASA to pay a one-time fee to the State. Once OWASA has a Level-1 allocation, water purchase rates from Cary would be lower since it would be considered to have come from part of OWASA's allocation. He explained that in the future, Cary or Durham can decide not to sell their water out of their own allocation. OWASA would not purchase water until just before entering into a stage 1 water shortage. He stated that it is recognized and respected that the Board disagrees with the suggested resolution but that it was adopted by OWASA's Board. He explained that Stage 1 thresholds depend on times of year and water volumes but, in May, it should be 70% full to avoid entering a Stage 1 water shortage.

30% ENERGY EFFICIENCY BUILDING CODE – LOCAL BILL

Steve Stewart, Town Manager, stated that the Town reviewed several properties for selection in a Duke Energy pilot program but none of the areas were selected.
