Carolyn Elfland, the Associate Vice Chancellor for Campus Services with UNC, explained that the University is reviewing various alternatives involving the relocation of certain components of the proposed plans but have not made any final decisions.

Alderman Lavelle stated that a lot of kids from Lake Hogan Farms and Fox Meadow are using the greenway to get to Morris Grove Elementary School.

DISCUSSION OF OWASA'S WATER SUPPLY PROJECTION AND JORDAN LAKE INTERESTS

The purpose of this item was for the Board of Aldermen to discuss OWASA's water supply projection and Jordan Lake interests. Specifically, Alderman Coleman discussed OWASA's water supply projections as they relate to growth and planning between now and the availability of the quarry and the use of the Jordan Lake allocation as an emergency measure only. He also discussed the Board's role, in respect to communication, with the Environmental Management Commission in the Jordan Lake allocations.

MOTION WAS MADE BY ALDERMAN COLEMAN AND SECONDED BY ALDERMAN SLADE TO REQUEST THAT THE TOWN OF CARRBORO PLANNING STAFF WORK WITH THE PLANNING STAFFS OF THE TOWN OF CHAPEL HILL, OWASA, AND UNC TO DISCUSS WATER SUPPLY PROJECTIONS AS THEY RELATE TO GROWTH AND PLANNING BETWEEN NOW AND THE AVAILABILITY OF THE QUARRY TO DETERMINE IF THERE WILL BE YEARS OF INCREASED WATER CONSTRAINT AND IF SO, TO DETERMINE IF THERE ARE ANY LAND USE PLANNING STRATEGIES THAT COULD BE CONSIDERED THAT WOULD MINIMIZE THE CONSTRAINT. THE BOARD EXPECTS THE TOWN OF CARRBORO'S PLANNING STAFF TO CONVEY THE CONTINUED PLANNING VISION OF CARRBORO DURING THE DISCUSSIONS. VOTE: AFFIRMATIVE ALL

Ed Kerwin, the Executive Director for OWASA, stated that it is essential that OWASA has the support of its jurisdictions regarding the access to, and retention of, OWASA's Jordan Lake allocation. OWASA will let the Board know if and when the formal support is necessary.

Discussion of OWASA's Water and Sewer Management, Planning and Boundary Agreement policy resolution regarding water purchases to mitigate the risk of shortage during periods of extended drought is to be scheduled for an upcoming meeting.

CONTINUED DISCUSSION OF THE TOWN MANAGER RECRUITMENT PROCESS

The Board continued discussion of the Town Manager recruitment process and suggested changes to the draft RFP. Staff was requested to contact various search firms to determine the appropriate amount of response time for the search firm RFP.

Alderman Coleman requested the addition of a "Specific Requirements" section to the RFP.
